No. 763 **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1797 OF THE ORDINANCE OF THE CITY OF PROVIDENCE, APPROVED NOVEMBER 7, 1966, AND ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE EAST SIDE PROJECT NO. R. I. R-4".

Approved December 9, 1977

Be it ordained by the City of Providence:

1. That Chapter 1797 of the Ordinance of the City of Providence, approved November 7, 1966, and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the East Side Project No. R. I. R-4" as heretofore amended, be and the same is hereby further amended as follows:

A. Paragraph numbered III. B. 4.c. (2)(b) entitled "Off-Street Parking" as contained in and set forth in Page 20 of that certain booklet entitled "East Side Renewal Project, Official Redevelopment Plan" which is a part of the aforementioned ordinance be and the same is hereby deleted and the following substituted therefor:

III. B. 4. c(2)(b) Off-Street Parking

Off-street parking shall be governed by the applicable provisions of the Zoning Ordinance of the City of Providence

2. That said Chapter 1797 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.

3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.

Transmitted herewith is an original and seven (7) copies of a proposed Ordinance to amend the Official Redevelopment Plan for the East Side Project.

The proposed Ordinance in Amendment will delete the controls for "Off-Street Parking" for that area bounded by Ives, Wickenden and Schofield Streets from the Official Redevelopment Plan and substitute the provisions of the Zoning Ordinance of the City of Providence in their stead. This change will enable the developer to construct a high-rise building with 100 units of elderly housing.

It is respectfully requested that the proposed Ordinance be placed on the docket for the City Council meeting of October 6, 1977.
