ORDINANCES SECOND READING

The following Ordinances were in City
Council January 26, 1989, Read and Passed
the First Time, and Are Returned for Pas-
sage the Second Time:

An Ordinance in Amendment of and In Addi-
tion to Article VI of the Code of Ordinances of
the City of Providence, Entitled: "Tax Abatement
on Rehabilitated Property," by Adding Sec. 21-
136, as Amended.

Be it ordained by the City of Providence:

Section 1. Article VI of the Code of Ordinances
of the City of Providence is hereby amended by
adding the following:

Sec. 21-136. Lien to be placed on Deed.

The City Solicitor shall cause a lien to be placed on the deed of the property to be conveyed in the total amount of the taxes abated. Said lien shall expire at the end of three years from the date the deed is recorded, or at such point that the Director of Inspection and Standards shall certify the building has been brought up to all appropriate codes.

Section 2. This Ordinance shall take effect upon its passage.

An Ordinance Amending the Appropriation Ordinance Chapter 1988-21, Approved July 1, 1988, by Transferring the Sum of \$15,000.00 from F.I.C.A. Account No. 1015 00225-3980 to Mary Elizabeth Sharpe Trust Fund.

Be it ordained by the City of Providence:

Section 1. Chapter 1988-21 of the Ordinances of the City of Providence, as approved July 1, 1988 and entitled: "An Ordinance Making an Appropriation of Two Hundred Seventeen Million Six Hundred Twelve Thousand, Fifty-Eight Dollars

(\$217,612,058) for the Fiscal Year Ending June 30, 1989" is hereby amended by transferring the sum of Fifteen Thousand Dollars (\$15,000.00) from F.I.C.A. Account No. 1015 00225-3980 to Mary Elizabeth Sharpe Trust Fund.

Section 2. This Ordinance shall take effect upon its passage.
