# RESOLUTION OF THE CITY COUNCIL

Approved November 23, 2004

Where as, in an effort to convert vacant lots into productive reuse, the Providence Redevelopment Agency is working to create affordable housing.

Now therefore, be it resolved that the taxes, in the amount of Two Thousand Four Hundred and Sixty-Six Dollars and Sixty-Eight Cents (\$2,466.68), assessed upon Assessor's Plat 63, Lot 456 (191-193 Manton Avenue), along with any associated interest, penalties and intervening taxes, are hereby abated in whole in accordance with Rhode Island General Law 44-7-23 and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40.


