Now, Therefore, Be It Ordained by the City of Providence:

Section 1. To defray the expenses of the City of Providence for the fiscal year ending June 30, 1978, the sums of money, or so much thereof, as are authorized by law, indicated in the accompanying schedule, are hereby appropriated for the objects and purposes, and in the amounts expressed therein, provided that payments thereunder shall be subject to the provisions of the Charter of the City of Providence, Chapter 832 of the Public Laws of 1940, enacted by the General Assembly of the State of Rhode Island at its January Session, A.D. 1940, and approved April 26, 1940, as amended, and subject to the provisions of the City Ordinances relative to the expenditures of money from the City Treasury. Title I Revenue Sharing, Fiscal Assistance to State and Local Government rules and regulations shall govern the portion of this Budget so designated.

Sec. 2. All moneys appropriated are to be expended under the direction of the respective department heads unless otherwise provided, subject to the approval of the Director of Finance. All moneys specifically earmarked with Federal Revenue Sharing Funds shall be so provided unless amended. Any unused Federal Revenue Sharing moneys not appropriated or not used shall not revert to surplus; but shall be reappropriated in the following fiscal year.

Sec. 3. The payments to the School Fund of the following estimated receipts, included in the

appropriation of \$39,300,800.00 for the support of the Public Schools for the City of Providence fiscal period 1977-1978, will be increased or decreased to conform with the actual amounts received from such sources during the City of Providence fiscal year 1977-1978.

- 4 Clerk Typist II

Sec. 55. The number of employees in the Department of *Administration to City Council* shall not exceed one (1). There shall be no more than:

- 1 Administrative Assistant to City Council

Sec. 56. The number of employees in the Department of *Superintendent of Weights and Measures* shall not exceed four (4). There shall be no more than:

- 1 Superintendent of Weights and Measures
- 1 First Deputy City Sealer
- 1 First Deputy City Weigher
- 1 Clerk IV

- 1 Accountant III
- 4 Clerk IV
- 7 Clerk III
- 1 Clerk II
- 1 Clerk Stenographer II
- 6 Clerk Typist II
- 1 Switchboard Operator I

Sec. 68. No person shall be appointed to, and the City Treasurer shall not pay, nor shall an officer or employee of the City issue a check for the payment of, nor pay any salary or compensation to a person holding, or claiming to hold a position in the classified service in any department which is in excess of the total number of positions or the number of any individual class of position provided herein for the particular department, provided; however, that with the approval of the Department Head and the Director of Finance, said maximum may be exceeded temporarily when regular employees are absent on vacation and the excess employees do not aggregate more than the number on vacation or during the absence of employees due to injuries received while discharging their duties as employees, or during the absence of employees on sick leave and it is necessary to employ temporary employees for the duration of the employees sick leave, or during the absence of employees who have been granted a temporary leave of absence, or when in the opinion of the Director of Finance, a temporary emergency exists.

Sec. 69. Where no maximum limit is fixed on the total number of positions or the number of any individual class of position in a Department, the number of persons appointed and employed shall be determined by the unexpended appropriation available.

Sec. 70. Chapter 1976-37 of the Ordinances of the City of Providence as approved November 10, 1976 with all amendments and additions thereto, is hereby repealed and all other Ordinances or parts thereof inconsistent herewith are likewise repealed.

Sec. 71. The limitations imposed by this Ordinance

as to the total number of persons or number of any individual class of positions in a department shall not apply to those members of the Armed Forces of the United States of America and of the Merchant Marine who have been honorably discharged therefrom and who at the time of their induction or enlistment were employees of the City of Providence, and request within forty days after discharge to return to the employ of the City, if the positions occupied or held by such persons at the time of their entrance into the service of the United States of America have not been included in the total number of positions or number of any individual class of position in a department, as fixed by this Ordinance.

Sec. 71.1. In the event it becomes necessary to eliminate or lay-off City Employees such lay-offs will be effected Not by Classification or Department but by Seniority on a City-Wide Basis.

Seniority shall be defined as "the total length of Service within the City of Providence." Those Employees with the least amount of Seniority on a City-Wide Basis shall be laid-off first.

Sec. 72. This Ordinance shall take effect upon its passage, and become retroactive as of July 1, 1977.

COUNCILMAN GORODETSKY Speaks on the proposed Amendment which Adds Section 71.1 to the above Ordinance, stating that:

The amendment is in poor form and perhaps can be cleared up, and requests that his remarks be incorporated in the Journal of Proceedings for this Meeting, so that if this ever goes to Court, the Court would be able to understand the intent of the Council.

He states that this Council cannot really interfere with the Labor Contract.

The Labor Contract presently contains Seniority Provisions and that the intent of this Council in voting the First Passage of Section 71.1 was:

No. 1 — To reinforce that any Lay-off would be by Seniority which they require already by contract and also if any jobs are to be eliminated that the people who would go first would be those with the least amount of Seniority, that there was never any intent to include the Police and Fire Department in the job elimination, since this Council was aware, as it is now, that it does not have too many police officers or too many firefighters.

Principally this amendment was offered, at best, because it was the intent of the Council that in the job eliminations, the same type of Seniority would apply, as in an ordinary lay-off situation, and further the reason for the use of City-wide, when referring to Seniority on a "City-wide Basis," was so that those jobs that are to be eliminated would not prevent somebody from one department from going into another department, if he has Seniority, but it never was his intention to vote for that if it included Police and Fire, and I think I can safely state that it was the intention of this Council, and that if the statement that he has made is not correct, that

it is incumbent upon the Members of this Council, on this floor to make those facts known now or that means that they agree with what he has stated.

Read and Passed the Second Time, as Amended, on motion of COUNCILMAN LYNCH, seconded by COUNCILMEN JOHNSON and FLYNN by the following Roll Call Vote:

Ayes: Council President Haxton and Councilmen Addison, Ahern, Cirelli, Cola, Fagnoli, Flynn, Glavin, Johnson, McKiernan, Merola, Stravato and Xavier—13.

Not Voting: Councilman Bradshaw, Councilwoman Brassil and Councilmen Lynch and Turchetta—4.

Absent: Councilman Pearlman—1.

COUNCILMAN LYNCH requests of the Clerk as to the Disposition by His Honor the Mayor of the following Ordinance which was Passed the Second Time at this Meeting and Transmitted by the Clerk to the Executive Chamber for the Mayor's Consideration.

The Clerk informs that the Subject Ordinance was Returned to the Clerk with the following message. "I hereby Disapprove and Veto because Section 71.1 is Inconsistent with Other Provisions

of the Same Ordinance," /s/ Vincent A. Cianci, Jr., Mayor, July 18, 1977.

On Motion of **COUNCILMAN LYNCH**, seconded by **COUNCILMAN ADDISON**, it is Voted to Receive the Mayor's Veto Message and the Said Ordinance be Reconsidered.

This motion being seconded by **COUNCILMAN ADDISON**, and Passed.

COUNCILMAN LYNCH moves that the Ordinance be Amended by Inserting in Line 1 of the title following the word "An" the word "Emergency"; following the Title Insert the following Preamble "WHEREAS, The Adoption of this Ordinance, as an Emergency Measure, is Necessary in the Welfare of the Citizens of this City."; in Section 72, following the word "This" in the first line, insert the word "Emergency" and to delete in Its Entirety "Section 71.1," and that the Said Ordinance, as Amended, be Passed as an Emergency Ordinance.

This Motion being seconded by **COUNCILMAN ADDISON**, is Put to Vote and Fails of Passage, by the following Roll Call Vote, the

Number of Votes of the Members of the City Council being Less than Three Quarters (3/4) of Its Membership having Voted in the Affirmative, by the following Roll Call Vote:

An Ordinance in Amendment of Chapter 1977-30, Approved July 5, 1977 Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 1976-37 Approved November 10, 1976, as Amended, be further Amended by Deleting Section 71.1, in Its Entirety and Passed the First Time as Amended.

This Motion being seconded by **COUNCILMAN ADDISON**, is Put to Vote and Passed, by the following Roll Call Vote:

The following Ordinance is Incorporated on the Printed Docket of This Meeting, Accordingly is Not Subject to the Suspension of Rule 16 of the Rules of the City Council for the Ensuing Term 1975-1979:

An Ordinance Providing for the Assessment and Collection of 1977 Taxes in the Sum of Sixty-Five Million, Seven Hundred Thousand Dollars (\$65,700,000.00) being Based on One Hundred Per Cent (100%) of the 1977-1978 Fiscal Year Tax Collection, as Amended.

On Motion of COUNCILMAN LYNCH, seconded by COUNCILMAN ADDISON, it is Voted to Lay this Ordinance on the Clerk's Desk.

On Motion of COUNCILMAN LYNCH, seconded by COUNCILMAN ADDISON, it is Voted to Suspend Rule 2 of the Rules of the City Council in Order to Allow the City Council to Meet on a Day Other than Provided in Said Rule 2.

PERSONAL PRIVILEGE

COUNCILMAN HENRIES Requests and is Granted the Floor on a Point of Personal Privilege and Reads the following:

Mr. President and Members of the City Council: A few days ago, we received a report on the Utilization of Minority group members and Women in City Employment.

After reading this report, it is apparent to me that this city has made little or no progress toward the goal of the Affirmative Action Plan since its inception in 1975. This report substan-

tiates my belief that there is racism and bigotry in our city's system.

I would like to state some information and let my fellow colleagues and other citizens draw their own conclusion:

In one of our city departments, there is an employee who has worked for the city for approximately twenty-six years, a college graduate who has been an able assistant to her superiors in her department, and yet does not earn \$10,000. yearly. The employee happens to belong

to two minority groups — As a Black and as a woman.

We are probably asking why she has not left the city's employ. The reason that she gives is that she loves people and in her position she is able to do things for them; to her this compensates for the deficiency as far as money is concerned, even though it does not conform to the Affirmative Action Plan.

This is just one example to point out the ineffectiveness of the Affirmative Action Plan as it now functions.

After submitting the original Affirmative Action Plan to the Mayor and informing him that no less an effort would succeed, I then concluded that the plan would not have the effectiveness that it was originally designed for — because of amendments and deletions made by the Mayor's office.

About nine months ago, I made a request to a member of Congress seeking assistance on Affirmative Action. I have been informed that the Federal government will provide me with technical assistance. The Equal Employment Opportunities Commission in Washington has also offered their services.

It is known that Providence receives a substantial amount in Federal dollars and in order to be deserving of this aid, it is essential that we deliver results rather than just lip service in the area of Affirmative Action.

It is necessary that we, as Councilpeople and the Mayor, as Chief Executive, be responsible for the implementation of a working Affirmative Action Plan for the City of Providence and that this plan be adhered to.

COUNCILMAN ADDISON Requests and is Granted the Floor on a Point of Personal Privilege speaking on the matter of the subject of the Affirmative Action Plan and reported the history starting in March, 1975 and the Executive Order by the Mayor that all people irrespective of Age, National Origin or Sex be afforded all Equal Opportunities and that the City of Providence had a Mayor's Task Force which was to be developed via the Human Relations Commission and Chaired by Ben Little, at that time; his sponsorship of a Resolution passed by the City Council mandating its provisions and of the fact that in September, 1975 the Mayor submitted his Affirmative Action Plan which was not all inclusive of the Task Force Plan; and of his attendance at many functions where the Mayor was quite proud of his Plan as one of the best in the country; the February, 1977 Resolution of the Council, co-sponsored by himself and Councilman Henries noting that the Mayor's Plan did not live up to his commitments and that as Chairman of the Committee on Public Welfare the intent to have Public Hearings within the next few weeks on the subject.

ADJOURNMENT

There being no further business, on motion of COUNCILMAN LYNCH, seconded by COUNCILMEN ADDISON, ALMAGNO, FLYNN, MANSOLILLO, MEROLA, TOMASSO and TURCHETTA the City Council adjourns at 10:15 o'clock P.M. (E.D.T.) to meet again on THURSDAY, JULY 21, 1977 at 8:00 o'clock P.M. (E.D.T.).
