

RESOLUTION OF THE CITY COUNCIL

No. 590

Approved December 5, 1966

WHEREAS, there are presently located in the City of Providence certain structures which are in a dilapidated and deteriorated condition; and

WHEREAS, the City of Providence is vitally interested in the preservation and rehabilitation of neighborhoods throughout the City; and

WHEREAS, the demolition of certain of these structures will serve to promote the preservation and rehabilitation of these neighborhoods; and

WHEREAS, the owners of certain of these dilapidated and deteriorated structures are willing to convey title to these structures and to the land upon which they are located to the City of Providence without cost to the City; and

WHEREAS, by the acceptance of these deeds, the City of Providence will be enabled to demolish these structures with funds previously appropriated,

NOW, THEREFORE, BE IT RESOLVED, that the City of Providence hereby accepts deeds in fee simple to the land and buildings hereinafter described from the owners thereof:

1. Land and buildings located on the easterly side of Aplin Court, designated as Lot 29 on that plat entitled "Plat of House Lots belonging to the Heirs of John Andrews, Surveyed and Platted by S.B. Cushing March 1884", recorded in Plat Book 17 at page 2, and (copy) on Plat Card 469, conveyed to the City of Providence by William J. Lonergan, Mae T. Lonergan and Katherine M. Lonergan.

2. Land and buildings located on the northeasterly side of Potters Avenue, designated as Lot No. 3 on that plat entitled "Plat of House Lots in Cranston belonging to Dr. A.C. Hawes & Bro., outlines surveyed by H.F. Walling July 1853, Drawn April 1854 by W.J. Harris," recorded in Plat Book 10 at page 1 and (copy) on Plat Card 257, conveyed to the City of Providence by Samuel H. and Esther Wilk.

3. Land and buildings located at the corner of Grand View and Knowles Streets, designated as Lots 38 and 39 on that plat entitled "Pleasant View Plat of house lots lying between North Main and Camp Streets, belonging formerly to Samuel Hedley, surveyed and platted May 1869 by C.E. Paine" recorded in Plat Book 8 at page 21 and (copy) on Plat Card 218, conveyed to the City of Providence by Fad Enterprises, Inc.

4. Land and buildings located on the westerly side of Padelford Street, designated as Lot 11 on that plat entitled "Plat of the Holbrook land on Earles Street belonging to Samuel Hedley, surveyed and platted November, 1869 by C.E. Paine", recorded in Plat Book 7 at page 27 and (copy) on Plat Card 201, conveyed to the City of Providence by John F. and William J. Jennings.

5. Land and buildings located on the northeasterly side of Messer Street, comprising the southerly portion of Lot 25 on that plat entitled "Drawn by C.E. Paine Aug. 6, 1868", recorded in Plat Book 11 at page 7 and (copy) on Plat Card 284, conveyed to the City of Providence by David Chernick.

6. Land and buildings located at the southwesterly corner of Sayles and Searle Streets, described as follows:

Beginning at the southwesterly corner of Sayles and Searle Streets, thence running westerly along the southerly line of Sayles Street, 4895 feet to a pin; thence turning and running southerly 43.41 feet to another steel pin; then turning and running easterly 5.08 feet to a wooden stake; then turning and running southerly 31.70 feet to a wooden stake in the line of land owned now or lately of Frederick L. Hepburn et ux.; thence turning and running easterly 43.87 feet to Searle Street; thence turning and running northerly along the westerly line of Searle Street 75.11 feet to the point of beginning, subject to sewer easements and encumbrances of record, conveyed to the City of Providence by Anthony Iavarone and wife, Frances Iavarone and John Iavarone and wife Marie Iavarone.

7. Land and buildings located on the northerly side of Gallup Street, described as follows:

No. **AN ORDINANCE** AMENDING CHAPTER 1633 OF THE
ORDINANCES OF THE CITY OF PROVIDENCE, 1964 (Approved August 17, 1964),
RELATING TO SALARIES OF COUNCILMEN.

Approved

Be it ordained by the City of Providence:

SECTION 1. Chapter 1633 of the Ordinances of the City of Providence, 1964 (Approved August 17, 1964), Relating to Salaries of Councilmen, is hereby amended to read as follows:

"The salary to be paid to each member of the Council in accordance with the provisions of Section 13 of the Charter shall be TWO THOUSAND FIVE (\$2,500) DOLLARS per year, payable monthly."

SEC. 2. This Ordinance shall take effect on the first Monday in January, 1967.
