



Gentlemen:

At the request of Council Resolution #607, dated December 6, 1954, the traffic engineer has studied the advisability of installing STOP signs on Prudence Avenue with its intersection with Ethan Street.

During the three year period from November 1, 1951 to October 31, 1954, only four accidents have been reported at the intersection. The traffic volumes through this intersection are extremely low with an average afternoon hourly volume of less than one vehicle per minute entering the intersection from all approaches. The sight distances are excellent on three of the four corners and do not offer a hazardous condition in themselves.

In view of our findings, we feel that no intersection control is warranted at Prudence Avenue and Ethan Street at the present time.

Gentlemen:

At the receipt of a petition to the City Council, the Traffic Engineer has studied the advisability of installing a traffic signal light at the intersection of Charles Street and Greeley Street.

This location is a "T" intersection and by itself presents a very small problem as far as traffic control is concerned. There is very little traffic on Greeley Street with the main traffic flows running straight through on Charles Street in both directions. There are also crosswalks painted at this location to provide for pedestrian crossing.

In the three year period from October 1, 1951 to September 30, 1954, only three accidents have been reported in this area. In view of these findings, we feel that a traffic signal is not warranted at the intersection of Charles Street and Greeley Street.
