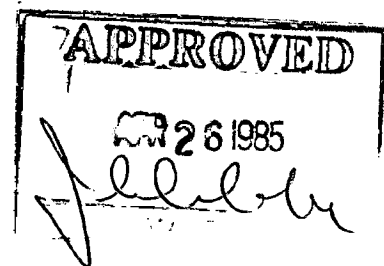

It is enacted by the General Assembly as follows:

SECTION 1. Chapter 29-6 of the General Laws entitled "State Aid to Libraries" is hereby amended by adding thereto the following section:

29-6-8.1. Aid to the Principal Providence Public Library. -- The General Treasurer shall toward the partial cost of the operation of the downtown Providence Public Library on or before August 1, pay to the Treasurer of the Providence Public Library, an amount equal to one dollar (\$1) times the number of visitors utilizing the downtown principal library in the previous calendar year upon demand and certification by the Chief Librarian of the number of such visitors.

SECTION 2. This act shall take effect upon passage.

EXPLANATION
BY THE LEGISLATIVE COUNCIL

AN ACT
RELATING TO STATE AID TO THE PROVIDENCE LIBRARY

This act provides for State Aid to the downtown Providence Public Library an amount equal to one dollar (\$1) times the number of visitors utilizing the library each year.
