

Ladies and Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Chapter 1977-15 of the Ordinances of the City of Providence approved April 28, 1977, as amended, and Title 45, Chapters 31-33 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the Federal Hill East Redevelopment Project.

1. The Agency proposes the sale of Parcel 4B consisting of 893 sq. ft. of land as delineated on the attached map for the disposition price of \$3,570.00 to Jane L. Mayerson of Sakonnet Point Farm, Little Compton, Rhode Island 02837 for residential and commercial fringe parcel development.



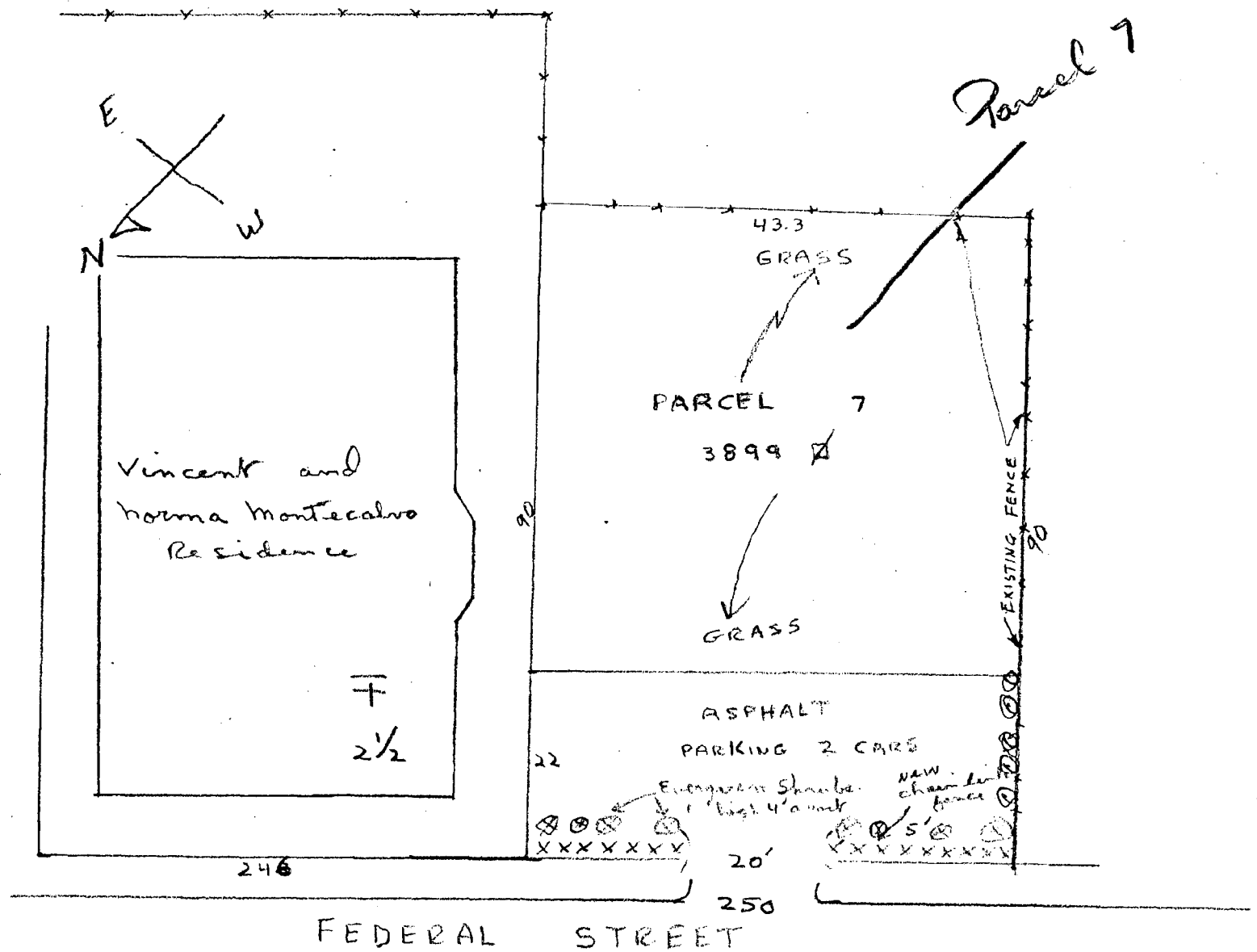
