Doyle who passed away on May 30, 1959 in the 97th year of his age. More than 50 years ago Mr. Doyle represented the citizens of the Old 4th Ward in the Common Council of the City of Providence. The records show that he served from January 1905 to January 1906 and again from January 1910 to January 1921. He maintained an active interest in civic affairs until his last illness.






