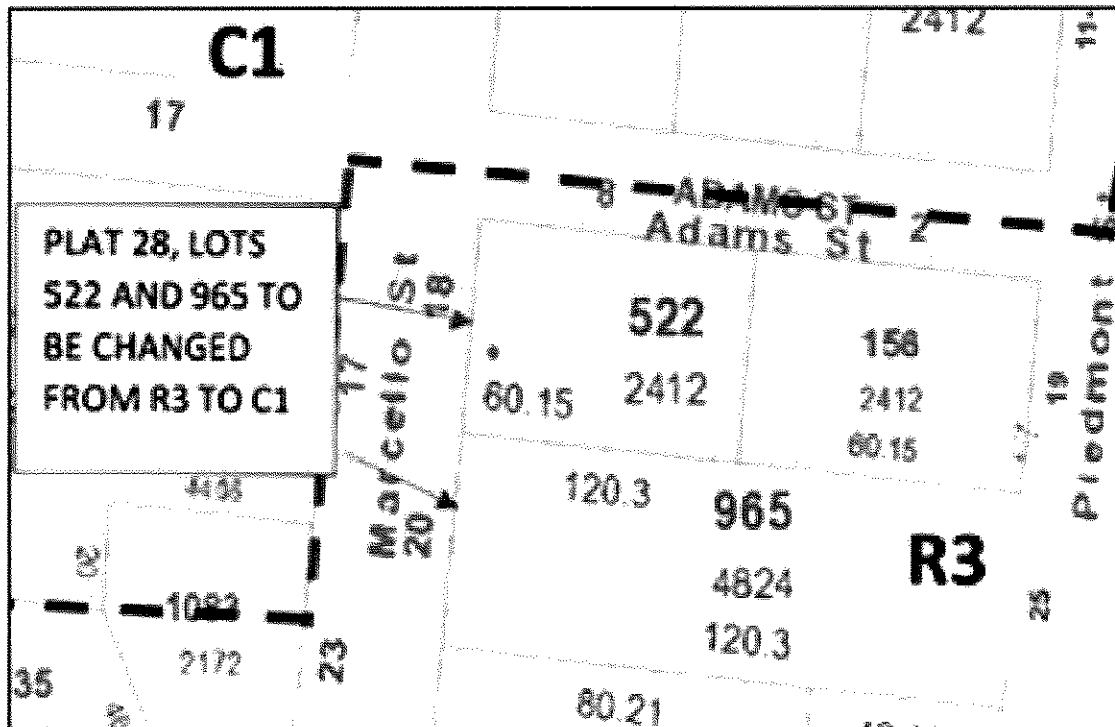

h. Notwithstanding provisions in this ordinance to the contrary, parking lots in the D-1 District that were permitted by variance or other zoning relief granted by the City and in effect as of March 19, 2020, but for such approvals would have expired thereafter, the expiration date for such approvals shall be tolled until December 31, 2024.

WHEREAS, Coach Thomas Spann is a Hall of Fame member for the Rhode Island Interscholastic League and the Rhode Island Track Coaches Association; and

WHEREAS, Coach Thomas Spann received the honor of serving as a member of the 1996 Olympic Torch Relay Team; and

WHEREAS, He is a dedicated public servant who has served the City of Providence in the Recreation Department for many years and is the recipient of the 2011 Ben Mondor Community Service Award by Words Unlimited which honors Rhode Island's top athletes and coaches; and

WHEREAS, In 2014 Coach Thomas Spann was the New Balance National Coach of the Year; and

WHEREAS, Coach Thomas Spann's athletes have set forty-seven (47) records with sixteen (16) still standing; and

WHEREAS, Coach Spann's desire to share his passion led him to create the Providence Cobras youth track club, helping athletes of all skill levels from Providence and beyond in various sports of track and field grow and reach their full potential; and

WHEREAS, Coach Spann is a Providence icon because of his leadership and dedication to the community as well as his impact on the lives of the thousands of students he has coached and mentored over the years.

Resolution Expanding the Rosa Parks Drive Ceremonial Designation for the entirety of
Prairie Avenue.

WHEREAS, In June 1984 the Providence City Council passed a resolution establishing Rosa Parks Drive along a section of Prairie Avenue in recognition of one of the true icons of the civil rights movement; and

WHEREAS, Rosa Parks is most widely known for refusing to give up her seat to a white passenger which triggered the 1956 bus boycott in Montgomery, Alabama that ultimately resulted in the city having to repeal the laws around segregated seating on buses; and

WHEREAS, The revitalization of the school would not have been possible if it were not for the dedication of Councilman Nicholas Narducci who has worked tirelessly advocating for the restoration of the property; and

WHEREAS, The City Council of the City of Providence has under its powers and authorities the ability to name city buildings.

Resolution Requesting the General Assembly to enact Legislation Authorizing the City of Providence to Finance a Contribution towards the Unfunded Pension Liability of the Employee Retirement System of The City of Providence by the Issuance of Bonds in a Principal Amount Not To Exceed \$515,000,000.

WHEREAS, The City Council of the City of Providence endorses and supports the issuance of general obligation bonds in order to finance a contribution towards the unfunded pension liability of the employee retirement system of the City; and

WHEREAS, Special legislation approved by the General Assembly is required in order for the City to issue bonds for that purpose.

NOW, THEREFORE, BE IT RESOLVED, That the City Council hereby requests that the General Assembly enact legislation authorizing the City to issue general obligation bonds to finance a contribution towards the unfunded pension liability of the Employee Retirement System of the City.

BE IT FURTHER RESOLVED, That the City Council's support for such general obligation bonds is contingent upon the following financial guardrails being implemented for the life of such bonds:

1. The sum of the pension obligation bond payments and the City's Actuarial Determined Contribution (ADC) shall not be less than the Fiscal Year 2022 ADC of \$93.1 million annually for the first ten years of the bond.
2. The City shall not close any pension obligation bonds without City Council approval, and such bonds shall not have an interest rate in excess of 5%.
3. The expected annual rate of return shall not exceed seven (7%) percent.
4. The salary scale shall not exceed three (3%) percent per the current actuarial experience study.
5. The City shall make 100% of its annual ADC payments.

BE IT FURTHER RESOLVED, That the City Solicitor, working with Bond Counsel for the City, ensure that the appropriate legislation is submitted in a timely manner to the Rhode Island General Assembly.

BE IT FURTHER RESOLVED, That the City Council is fully committed to pursuing all available pension reforms in order to address the unfunded pension liability of the City's Employee Retirement System.

BE IT FURTHER RESOLVED, That this Resolution shall take effect upon its passage.
