No. 564 **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1979-26 OF THE ORDINANCE OF THE CITY OF PROVIDENCE, APPROVED JUNE 22, 1979 AND ENTITLED, "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE WEST END PROJECT" FOR ADDITIONAL ACQUISITION.

Be it ordained by the City of Providence:

1. That Chapter 1979-26 of the Ordinance of the City of Providence, approved June 22, 1979 and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the West End Project" as amended by the following Ordinances of the City of Providence: Chapter 1986-39 (June 26, 1986); Chapter 1988-32 (July 24, 1988); Chapter 1990-22 (November 5, 1990) and Chapter 1994-57 (December 27, 1994) is hereby further amended as follows:

A. Add the following properties to the acquisition list in Chapter E. Section 2. entitled "Proposed Acquisition" as contained in and set forth in Page 12 of that certain booklet entitled, "West End Official Redevelopment Plan, 1979", which is part of the aforementioned Ordinance.

B. All maps of the aforementioned Official Redevelopment Plan shall be amended to indicate the proposed acquisition.

2. That said Chapter 1979-26 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.

3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.
