No. 484 **AN ORDINANCE** FIXING THE SALARY OF THE MAYOR OF
THE CITY OF PROVIDENCE AT TWENTY THOUSAND (\$20,000.00)
DOLLARS PER YEAR

Approved August 17, 1964

Be it ordained by the City of Providence:

SECTION 1. The salary to be paid the Mayor of the City of Providence shall be TWENTY THOUSAND (\$20,000.00) Dollars per year, payable weekly.

Sec. 2. This Ordinance shall take effect on the first Monday in January, A.D. 1965, and thereupon Chapter 760 of the Ordinances of 1930, Chapter 537 of the Ordinances of 1951, and all other Ordinances or parts thereof inconsistent herewith shall stand repealed.

No. 485 AN ORDINANCE AMENDING CHAPTER 2, SECTION 4, OF THE
REVISED ORDINANCES, 1946, AS AMENDED, RELATING TO SALARIES
OF COUNCILMEN

Approved August 17, 1964

Be it ordained by the City of Providence:

SECTION 1. The first paragraph of Chapter 2 of Section 4 of the Revised Ordinances of the City of Providence, 1946, as amended by Chapter 190 of the Ordinances 1948 and Chapter 573 of the Ordinances of 1952, is hereby further amended to read as follows:

The salary to be paid to each member of the Council in accordance with the provisions of Section 13 of the charter shall be Two Thousand (\$2,000.00) Dollars per year, payable monthly; provided, however, the salary to be paid to the President of the City Council shall be Two Thousand Six Hundred (\$2,600.00) Dollars per year, payable monthly.

SEC. 2. This Ordinance shall take effect on the first Monday in January 1965.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1565 of the Ordinances of the City of Providence, as approved September 24, 1963 entitled: "An Ordinance Making Appropriation of \$44,468,244.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1964", as amended, is hereby further amended by appropriating the sum of Thirty Thousand (\$30,000) Dollars to GENERAL PUBLIC ASSISTANCE, ITEM 1.

SECTION 2. The said sum of Thirty Thousand (\$30,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and the City Treasurer to transfer a like amount from the Reserve for General Public Assistance to a receipt account in the General Fund to be known as Reserve for General Public Assistance.

SECTION 3. The estimated receipts are hereby increased by the sum of Thirty Thousand (\$30,000) Dollars.

Chapter 1565 of the Ordinances of the City of Providence, as approved September 24, 1963 entitled: "An Ordinance Making Appropriation of \$44,468,244.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1964", as amended, is hereby further amended by appropriating the sum of Fifteen Thousand Six Hundred (\$15,600) Dollars to BOARD OF CANVASSERS, as follows:
ITEM 0 - \$10,800, and ITEM 1 - \$4,800.

SECTION 2. The said sum of Fifteen Thousand Six Hundred (\$15,600) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and the City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Fifteen Thousand Six Hundred (\$15,600) Dollars.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1565 of the Ordinances of the City of Providence, as approved September 24, 1963 entitled: "An Ordinance Making Appropriation of \$44,468,244.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1964", as amended, is hereby further amended by appropriating the sum of Eighty Thousand (\$80,000) Dollars to an account to be known as, "PURCHASE OF LAND FOR RECREATION PURPOSES".

SECTION 2. The said sum of Eighty Thousand (\$80,000) Dollars as thus added and appropriated shall be obtained by increasing the estimated receipts from Property Taxes-Prior Years by the sum of Eighty Thousand (\$80,000) Dollars.

SECTION 3. The City Controller and the City Treasurer are hereby authorized and directed to transfer this appropriation from the General Fund to an account in the Capital Funds to be known as, "Purchase of Land for Recreation Purposes". Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.
