No. 3467 AN ORDINANCE IN AMENDMENT OF CHAPTER 4 BY AMENDING SECTION 4-35 WHICH IS ENTITLED: "REDEMPTION OF IMPOUNDED DOGS OR OTHER ANIMALS"

Approved June 6, 1982

Be it ordained by the City of Providence:

IN CITY COUNCIL FIRST READING JUN 1 1982

SECTION 1. Chapter 4 of the Code of Ordinances of the City of Providence is hereby amended by amending Section 4-35, which shall read as follows:

"Section 4-35. (a) The owner shall be entitled to regain possession of any impounded dog or other animal except as hereinafter provided in the cases of certain dogs, at any time upon the payment of impoundment fees set forth herein.

(b) Any dog or other animal impounded under the provisions of this article and not reclaimed by its owner within five (5) days, may be humanely destroyed by the dog officer, have its possession transferred to the Society for the Prevention of Cruelty to Animals as provided for in section 4-34(b), or placed in the custody of some person deemed to be a responsible person, who will agree to comply with the provisions of this article and such other regulations as shall be fixed by the dog officer; provided, however, that such person pay to the dog officer an adoption fee of \$5.00."

SECTION 2. This Ordinance shall take effect upon its passage.
