WHEREAS, Council Members of the City of Providence have, Pursuant to Section 406 of the Providence Home Rule Charter of 1980, requested the City Clerk, in writing, to call a Special Meeting of the City Council to be held on the 24th Day of July, 1992 at 5:30 o'clock P.M. (E.D.T.) for the purpose of Enacting the following:

An Ordinance Providing for the Assessment and Collection of 1992 Taxes in a Sum Not Less than One Hundred Sixty-Eight Million One Hundred Twenty-Four Thousand Nine Hundred Dollars (\$168,124,900) and Not More than One Hundred Ninety-One Million Six Hundred Seventy-Eight Thousand Eight Hundred (\$191,678,800) being based on One One Hundred Percent (100%) of the 1992-1993 Fiscal Year Tax Collection.

An Ordinance Making an Appropriation of Two Hundred Seventy Million, Seven Hundred Eighty Four Thousand One Hundred Seventeen Dollars (\$270,784,117.00) for the Fiscal Year Ending June 30, 1993, as Amended.

An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 1991-25 approved July 24, 1991, as Amended.

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Ordinance Chapter 1991-24, approved July 24, 1991, as Amended.

You are therefore, hereby commanded and required to summon each Member of the City Council to that Special Meeting, as Called.

HEREOF, Fail Not, and make a true return of this Warrant, with your doings thereon.
