No. 526 AN ORDINANCE ESTABLISHING THE SALARIES
OF THE CHAIRMAN AND THE MEMBERS OF THE SCHOOL COMMITTEE.

Approved December 20, 1968

Be it ordained by the City of Providence:

SECTION 1. The members of the School Committee shall be compensated at the rate of TWO THOUSAND (\$2,000) DOLLARS per year, commencing from the date of their appointment and qualification, and terminating when their successors are duly appointed and qualified.

SEC. 2. The chairman of the School Committee shall receive a compensation in the amount of TWENTY-FIVE HUNDRED (\$2500) DOLLARS per year, commencing on the date he was elected chairman and terminating on the date when his successor is elected chairman.

SEC. 3. This Ordinance shall take effect upon its passage and shall be retroactive to the day the School Committee was appointed ^{and qualified} by His Honor the Mayor.

CLASS DEFINITION: Responsible clerical work assisting in the preparation and maintenance of records of a court of law, acts as Clerk of Municipal Court, in the absence of the Clerk and Deputy Clerk, and related work as required.

DISTINGUISHING FEATURES OF WORK: Work involves responsibility for maintaining assigned court records and acting in the capacity of Clerk of Municipal Court in the absence of the Clerk and Deputy Clerk. Work assignments are received from superior and work is reviewed for compliance with instructions.

ILLUSTRATIVE EXAMPLES OF WORK: Attends court sessions and obtains such records as may be requested by the judge. Keeps records of cases and their disposition. Collects fines. Lists stubs on unpaid motor vehicle law violations. Collects motor vehicle law violation fines or schedules hearings in particular cases as preferred by violator. Keeps records and makes reports. Acts as Clerk of Municipal Court in the absence of the Clerk and Deputy Clerk.

DESIRABLE KNOWLEDGES, SKILLS AND ABILITIES: Knowledge of modern office procedures and equipment. Thorough knowledge of business arithmetic. Ability to understand and carry out complex written and oral instructions. Ability to operate a typewriter. Ability to establish satisfactory working relationships with City employees and the public.

QUALIFICATIONS REQUIRED FOR APPOINTMENT: Graduation from a standard high school and preferably additional business school training. Considerable responsible clerical experience.

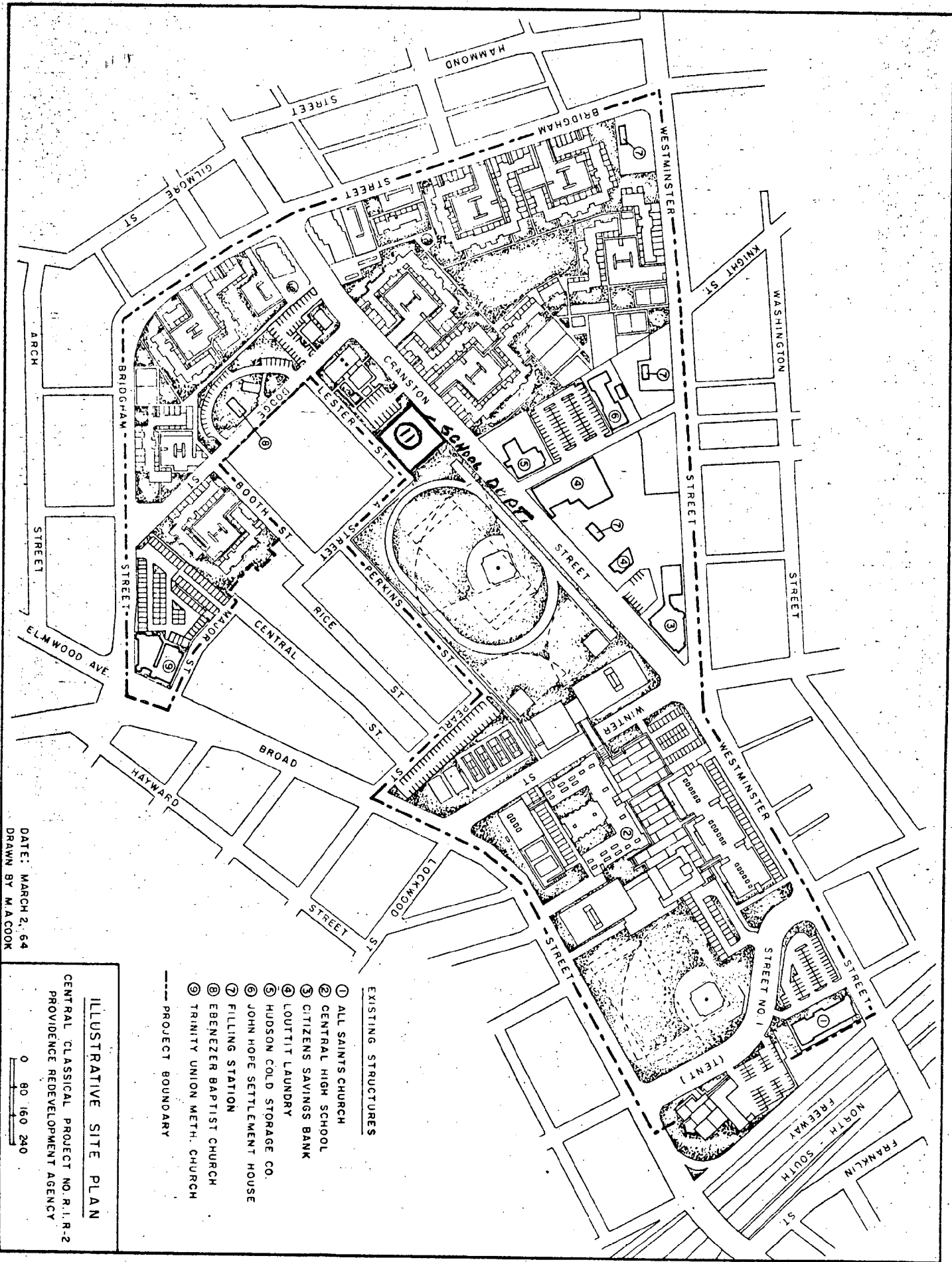

KNOWN ALL MEN BY THESE PRESENTS that the PROVIDENCE REDEVELOPMENT AGENCY, of the City and County of Providence, State of Rhode Island, a public body corporate and politic created by the General Assembly of the State of Rhode Island for and in consideration of the sum of Four Thousand Three Hundred Fifty Two and 20/100 (\$4,352.20) Dollars to it paid by City of Providence, a municipal corporation created under the laws of the State of Rhode Island, situated in the City and County of Providence, in said State, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey unto the City of Providence, its successors and assigns forever the following tract or parcel of land situated in the City of Providence, County of Providence, State of Rhode Island, bounded and described as follows:

Parcel I

Beginning at a point in the northwesterly corner of that parcel of land herein described, said point also being the northeasterly corner of that parcel of land now or formerly of the Catholic Interracial Center and lying easterly of the intersection of the northeasterly line of Dodge Street and the southeasterly line of Cranston Street a distance of two hundred forty-one and 00/100 (241.00') feet and lying on said southeasterly line of Cranston Street; thence running N 45°-37'-56"E along said southeasterly line of Cranston Street a distance of one hundred fifty-five and 11/100 (155.11') feet to a point on said street line; thence turning an interior angle of ninety degrees, thirty-five minutes, and seventeen seconds (90°-35'-17") and running S 44°-57'-21"E a distance of one hundred forty and 49/100 (140.49') feet to a point on the northwesterly line of Lester Street; thence turning an interior angle of eighty-nine degrees, sixteen minutes and nineteen seconds (89°-16'-19") and running S 45°-46'-20"W along said northwesterly line of Lester Street a distance of one hundred fifty-five and 11/100 (155.11') feet to a point on said street line; thence turning an interior angle of ninety degrees, forty-three minutes and forty-seven seconds (90°-43'-47") and running N 44°-57'-27"W along the easterly boundary line of that parcel of land now or formerly of the Catholic Interracial Center a distance of one hundred forty and 11/100 (140.11') feet to the point and place of beginning on the southeasterly line of Cranston Street;

TO HAVE AND TO HOLD the aforesaid premises with all the rights, privileges and appurtenances thereunto appertaining, except as set forth in the foregoing restrictions, protective covenants, conditions and reservations unto and to the use of the City of Providence, its successors and assigns forever.

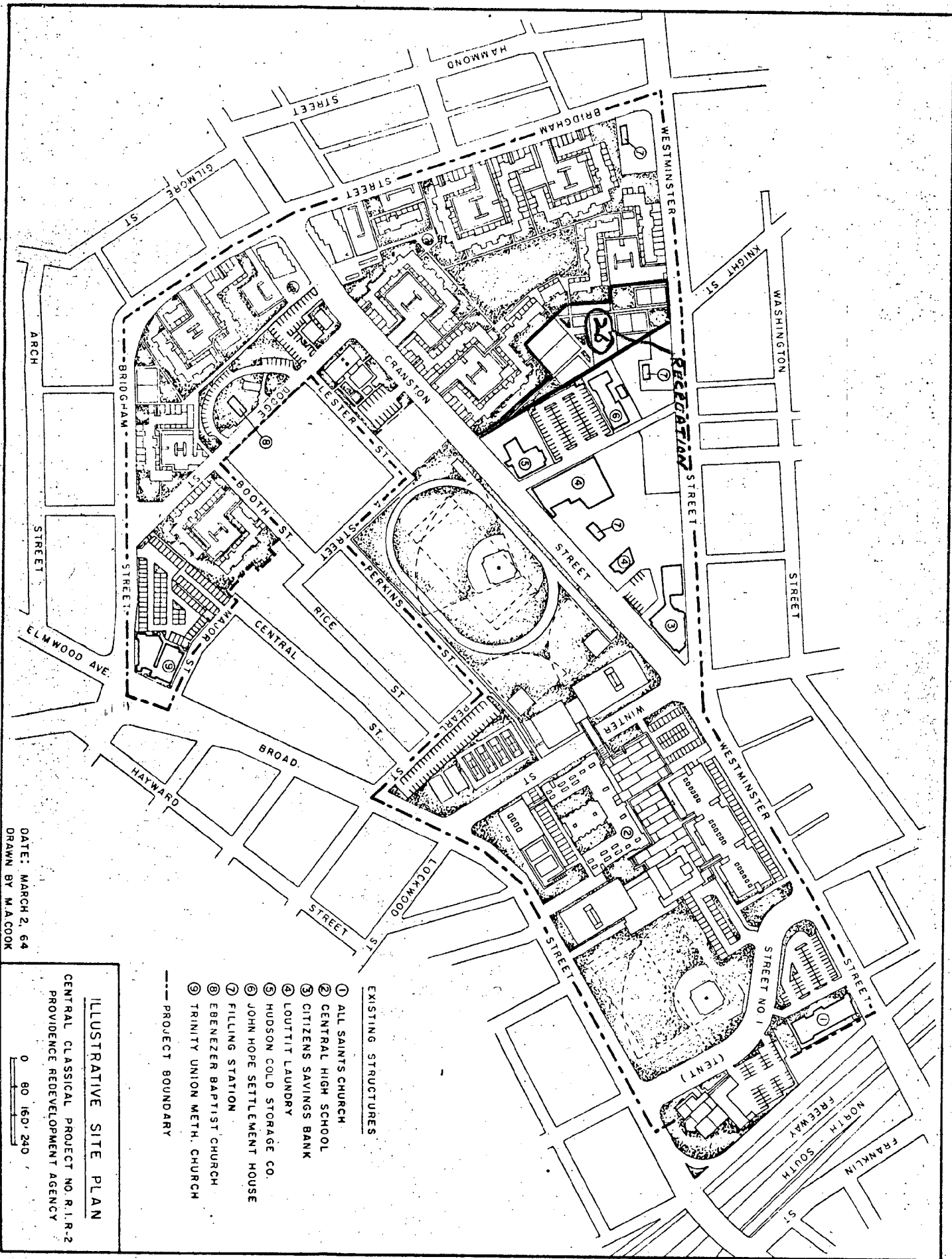

KNOW ALL MEN BY THESE PRESENTS that the PROVIDENCE REDEVELOPMENT AGENCY, of the City and County of Providence, State of Rhode Island, a public body corporate and politic created by the General Assembly of the State of Rhode Island for and in consideration of the sum of Nineteen Thousand Seventy and 00/100 (\$19,070.00) Dollars to it paid by City of Providence, a municipal corporation created under the laws of the State of Rhode Island, situated in the City and County of Providence, in said State, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey unto the City of Providence, its successors and assigns forever the following tract or parcel of land situated in the City of Providence, County of Providence, State of Rhode Island, bounded and described as follows:

Parcel 1

Beginning at a point on the northwesterly line of Cranston Street; said point lying S 45°-37'-56" W a distance of one hundred seventy-five and 81/100 (175.81') feet from the intersection of said northwesterly line of Cranston Street and the southwesterly line of Burgess Street;

thence, continuing S 45°-37'-56" W along said Cranston Street line a distance of twelve and 24/100 (12.24') feet to a point on said street line;

thence, turning an interior angle of seventy-eight degrees, forty-four minutes, eleven seconds (78°-44'-11") and running N33°-06'-15" W a distance of eighty-three and 00/100 (83.00') feet to a point;

thence, turning an interior angle of one hundred ninety-one degrees, fifteen minutes, forty-nine seconds (191°-15'-49") and running N 44°-22'-04" W a distance of one hundred ninety-five and 17/100 (195.17') feet to a point;

thence, turning an interior angle of two hundred seventy degrees, no minutes, no seconds (270°-00'-00") and running S 45°-37'-56" W a distance of one hundred eighteen and 00/100 (118.00') feet to a point;

thence, turning an interior angle of ninety degrees, no minutes, no seconds (90°-00'-00") and running N 44°-22'-04" W a distance of one hundred seventy and 31/100 (170.31') feet to a point;


