Under date of September 25, 1957, you forwarded to me a copy of a Resolution passed by the Providence City Council under date of September 20, 1957.

This Resolution requested me to investigate the use of certain sound equipment by the New Haven Railroad at a location north of the Smithfield Avenue Bridge in the City of Providence. It was stated in your Resolution that the sounds permitted by said amplifying equipment were particularly disturbing to residents in the surrounding areas.

The subject matter of your Resolution has been referred to the Railroad by this Division, and I am in receipt of a letter from the New Haven's Counsel, Mr. William E. Boyle, with reference to my request for an investigation of said amplifying equipment.

I am enclosing herein a copy of said letter for your files and I trust that as a result of the Railroad's action in this matter, that the disturbance to the residents of the areas affected will be greatly reduced, if not, in fact, eliminated.

PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body for abandonment, by the City of Providence, State of Rhode Island, of its right, title, interest and ownership of that certain strip of land and/or highway extending, to-wit, easterly from Wheaton Street to the wall on Congdon Street, said area shown and designated in the Tax Assessors' Office and records in said City of Providence, on and as PLAT 10 said area holding a width of to-wit 24 feet, and a length of to-wit, 118 feet from said corner of Wheaton Street to said wall at Congdon Street.

Petitioners represent that said area and section of Bowen Street is ungraded not curbed, impassable for vehicular travel, dangerous, unsafe and unfit for pedestrian travel.

That your petitioners, since September 28, 1955, have been the owners and in possession of Lot 196, Plat 10 aforesaid, being the to-wit, south easterly corner of said Bowen and Wheaton Streets, and described as follows:-

**That lot of land, with all buildings and improvements thereon, situated in the City of Providence and State of Rhode Island, on the southeasterly corner of Bowen Street and Wheaton Street, and laid out and delineated as Lot No. 3(three) on that plat entitled, "P. Allen's Lots on Wheaton & Congdon St." and recorded in the Office of the Recorder of Deeds in said Providence in Plat Book 4 at page 74 and (copy) on Plat Card No. 136."*

" Said lots bounds westerly on Wheaton Street fifty seven(57) feet, more or less, northerly on Bowen Street one hundred three and 8/10 (103.8) feet, more or less, easterly on land now or lately of the City of Providence fifty seven(57) feet, more or less, and southerly on land now or lately of said City of Providence ninety eight and 7/10(98.7) feet, more or less."

That the City of Providence has been the owner of Lot 193, said Plat 10, since to-wit, 1929, and that Amey W. Hart and Marthe B. Day have been the owners of Lots 152 and 610, aforesaid Plat 10, all said three lots abutting since 1944 and 1942 respectively on the aforesaid portion and section of the said Bowen Street.

That the said section and area of said Bowen Street described above is a steep hill extending up from said Wheaton Street to the wall on said Congdon Street, and is in such deplorable condition as to render entrance to petitioners' property and home on said lot No. 196, plat 10 and known as #77 Bowen Street, practicably inaccessible.

That your petitioners desire to level off and make usable the abutting and surrounding part of said highway to their said property and home, for safe and proper entrance and exit to their said property and to prevent the present unsafe and dangerous use of said highway and area as presently exists

Wherefore your petitioners respectfully request the City of Providence to abandon the aforesaid described area, section and portion of said Bowen Street to the use and possible enjoyment of the abutting owners thereto.



The portion of Bowen Street petitioned for abandonment extends from Wheaton Street easterly 103.98 feet to the northeast corner of lot designated as Lot No. 196 on Assessor's Plat No. 10, which is owned by the petitioners.

The land east and south of Lot 196 is city owned land known as Prospect Terrace.

Bowen Street, from Canal St. to Hope St. was named in 1805.

Bowen Street, between Congdon St. and Wheaton St., has never been received as a public highway and has been used by pedestrians only.

Located in the portion of the street petitioned for abandonment are A.T. & T. and N.E. Telephone Co. trunk lines to Boston and also lines serving people on the east side of Providence.

If any part of the street was to be abandoned, it should extend from Congdon St. to Wheaton St.

Since the portion of the street petitioned for abandonment has been in existence in it's present condition for more than one hundred and fifty years and the City has permitted the laying of telephone lines therein, we recommend that the petition be denied.

Your petitioner, Typesetting Service Company, is a Rhode Island corporation, whose office is at 211 Eddy Street, in the City of Providence, Rhode Island, and is the owner of a parcel of real estate located at the corner of Eddy and Clifford Streets in the City of Providence; this property is bounded southeasterly by Eddy Street and southwesterly by Clifford Street, the said streets making a "V" junction with the property of the petitioner. From Clifford Street, going southeasterly on Eddy Street, the street is a dead end now by reason of a bridge abutment that has been built as part of the Freeway System. The street serves no purpose as a highway, and in fact the continuance of this area, which is Eddy Street, is blocking the ingress and egress of vehicles and customers to the property of Typesetting Service Company, whose delivery entrance and parking area is located adjacent to Eddy Street. The Police Department has marked this area from Clifford Street along Eddy Street to the bridge abutment as a "detour". There is no person, individual, corporation, or otherwise, that has any interest on the portion of Eddy Street that abuts the property of the Typesetting Service Company.






The Narragansett Electric Company respectfully represents that it has for years, under due authority of the City of Providence, installed, maintained and operated extensive underground electrical facilities in Eddy Street; that such facilities are an important link between its Generating Stations and the underground network serving the center of the City and also serving its outlying sections; that it has but recently and at great expense made changes and improvements in its underground system in Eddy Street at the Freeway crossing, adjacent to the portion of Eddy Street you are now petitioned to abandon; that the street is also occupied by gas, water and sewer lines, that the closing of the street and the consequent relocation of all these facilities would impose undue expense and hardship on the utilities and the City without serving any useful public purpose; and that such abandonment would not be in the public interest.

Wherefore The Narragansett Electric Company prays that the petition for abandonment be denied.


Gentlemen:
