Regarding your letter of October 12, 1983, received at this office on October 17, 1983, concerning the elevator at Parenti Villa, please be advised of the following.


On September 27, 1983, the Providence Housing Authority noted a problem with elevator #2 at Parenti Villa. Otis Elevator Company was dispatched to tract down the cause of the erratic operation of that particular elevator. Although the problem was not isolated, a complete breakdown occurred on October 7 with elevator #2.

Otis Elevator originally estimated that repairs could take as long as 5-6 weeks to replace a burned-out motor. After a detailed inspection they found that it was not the case and they were able to make the repairs within 5 working days; service being restored on October 14, 1983.

Otis Elevator has been requested to provide this office with a full written report, detailing the extent and nature of their repair. I would be pleased to forward you a copy when received.


