ORDINANCE SECOND READING

The following Ordinance was in City Council January 5, 1978, Read and Passed the First Time and Is Returned for Passage the Second Time:

An Ordinance Granting the Consent of the City of Providence to the Acquisition of Its Property, Estate and Interest in Certain Real Property in the Downtown Providence Renewal Project by the Providence Redevelopment Agency.

Be it ordained by the City of Providence:

Section 1. Pursuant to the provisions of Title 45, Chapter 32, Section 25 of the General Laws of Rhode Island, 1956 (as amended) the City of Providence hereby consents to the acquisition by the Providence Redevelopment Agency by eminent domain proceedings, or by purchase, of the fee to, and all of the estate and interest of the City of Providence in and to the following described lots or parcels of land together with all buildings or improvements thereon and all air space and air easements in connection therewith, to wit:

ASSESSOR'S PLAT 19 (Nineteen), LOTS 31 (Thirty-one) AND 32 (Thirty-two) being generally described as the parking deck in front of Union Station and the east and west approaches thereto.

Sec. 2. The said acquisition is in conjunction with the Downtown Providence Renewal Project approved by the Providence City Council on February 14, 1977 by Chapter 1977-5 No. 64 AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR DOWNTOWN PROVIDENCE RENEWAL.

Sec. 3. This Ordinance shall take effect upon its passage.

Now, Therefore, be it Resolved, That the City Council hereby respectfully requests the Providence Redevelopment Agency to inform it periodically, as to their intended use for the expenditure of the One Million Dollar (\$1,000,000.00) Fund proposed to be Reserved for a Renewal Plan for the West End Section of the City Providence.

Resolution Authorizing the City of Providence to Purchase from the Town of North Providence, a Portion of the Water Supply System of Said Town, for Two Hundred Forty-Seven Thousand, Five Hundred Dollars (\$247,500.00), Payment to be Made Over a Period of Ten Years.

Whereas, The TOWN OF NORTH PROVIDENCE deems it advisable to arrange for a source of water from the CITY OF PROVIDENCE to the users in NORTH PROVIDENCE presently supplied water by the CITY OF PAWTUCKET, and

Whereas, The CITY OF PROVIDENCE is desirous of acquiring various fixtures consisting of pipes, mains, valves, connections, hydrants, etc. (hereinafter referred to as the "system"), from the TOWN OF NORTH PROVIDENCE, and

Whereas, The TOWN OF NORTH PROVIDENCE is desirous of selling said system to the said CITY OF PROVIDENCE, and

Whereas, The CITY OF PROVIDENCE is desirous of expanding the capacity of the Long Vue Reservoir on Mineral Spring Avenue in the TOWN OF NORTH PROVIDENCE, and

Whereas, The CITY OF PROVIDENCE is desirous of entering into an agreement relative to the tax assessment of its land on Mineral Spring Avenue in the TOWN OF NORTH PROVIDENCE and

Whereas, NORTH PROVIDENCE and PROVIDENCE have negotiated an agreement, a copy of which is hereto annexed and made a part hereof, and

Whereas, The Town Council of the TOWN OF NORTH PROVIDENCE has approved a resolution authorizing the TOWN to sell said system, and

Whereas, The Town Council of the TOWN OF NORTH PROVIDENCE ratified and approved the assessment of the land and improvements, including any extensions of the same in the future,

belonging to the PROVIDENCE WATER SUPPLY BOARD at Two Hundred and Fourteen Thousand, Nine Hundred and Eighty Dollars (\$214,980.00) as the total valuation for a period of ten (10) years from the execution of the agreement of sale, and

Whereas, The TOWN OF NORTH PROVIDENCE has agreed to sell said system to the CITY OF PROVIDENCE for the Sum of Two Hundred Forty-Seven Thousand, Five Hundred Dollars (\$247,500.00), payable without interest as follows:

(a) The sum of Twenty-Five Thousand Dollars (\$25,000.00) shall be paid by the CITY OF PROVIDENCE to the TOWN OF NORTH PROVIDENCE commencing the date on which the system is severed from the CITY OF PAWTUCKET;

(b) The sum of Twenty-Five Thousand Dollars (\$25,000.00) shall be paid by the CITY OF PROVIDENCE to the TOWN OF NORTH PROVIDENCE each year thereafter on the anniversary date of the first payment, and a final payment of Twenty-Two Thousand, Five Hundred Dollars (\$22,500.00) on the tenth (10th) anniversary date;

(c) Upon the final payment from the CITY OF PROVIDENCE to the TOWN OF NORTH PROVIDENCE, the TOWN OF NORTH PROVIDENCE shall deliver a good and sufficient bargain and sale deed to the system to the CITY OF PROVIDENCE.

Now, Therefore, be it Resolved by the City Council of the City of Providence:

(1) That the CITY OF PROVIDENCE shall purchase such portion of the water supply system of the TOWN OF NORTH PROVIDENCE lying within the boundaries of the TOWN OF NORTH PROVIDENCE in accordance with the terms and conditions of the copy of the agreement attached hereto;

(2) That the Mayor of the CITY OF PROVIDENCE shall cause the execution of a duplicate original for and in behalf of the CITY OF PROVIDENCE of said purchase and sale agree-

ment and to deliver and accept a duplicate original for and in behalf of the CITY OF PROVIDENCE.

Minute on the Life and Character of Colonel Robert E. Ricci, Late Chief of the Providence Police Department.

M I N U T E

Colonel Robert E. Ricci, late Chief of the Providence Police Department was born in Providence, Rhode Island, July 24, 1927, the son of Ernest Ricci and Grace Ricci.

He was educated in the Providence Public School System and graduated from Central High School, Providence, Class of 1944.

A Veteran of World War II, he served in the United States Navy and the Merchant Marines.

Colonel Ricci became a Member of the Providence Police Department in 1949, where he compiled a most enviable record in police work, gaining a number of citations. He advanced to the Detective Division in 1954 and subsequently became head of the Juvenile Division, and later head of the effective C-Squad.

His advancements in the Department was promotion to Sergeant in 1958; Lieutenant in 1962; Captain in 1968 and appointment as Chief of the Department in August, 1976.

Colonel Ricci, as a law enforcing agent, it has been stated, had no peers, his conduct as a policeman set the pattern of behavior for the entire Police Department.

Fair in his decisions, he was respected by his subordinates, for his concern of them and for his perfectionism.

Colonel Ricci came to the position of Chief without obligations to anyone, his selection was, without question, the result of his performance over the years as a police officer.

In respect to his memory, the citizens of Providence and of the State of Rhode Island, while shocked at his passing, at the early age of fifty years, will not easily forget his myriad of contributions to the society he literally gave his life for their protection.

Colonel Robert E. Ricci, as Chief of the Providence Police Department leaves this life, after having given his best as a person; devoted husband; son and father; devoted Roman Catholic layman and a most able law enforcer who truly was "One of God's Noblemen."

It is the fervent prayer of His Honor Mayor Vincent A. Cianci, Jr., the Members of the City Council, the personnel of the Police Department and his legion of friends, that his bereaved and devoted widow Margaret, their son Robert, Jr. and daughter Karen and his mother Grace take

consolation in his performance as one of the City of Providence's finest Policemen ever.

In being called to his eternal reward, all who knew him petition Almighty God, in his Divine Wisdom, to take unto Himself the soul of Colonel Robert E. Ricci, our late lamented brother.
