
On September 21, 1977 this department received from the City Clerk a copy of a Petition to the City Council for the abandonment of portions of Clarke Street and Towner Streets.

Subject: Referral No. 1987 - Abandonment of Clarke and Towner Streets

Gentlemen:

A communication from the Committee on Public Works dated September 19, 1977 proposes the abandonment of Clarke and Towner Streets. The petitioner is Mr. Richard C. Gower, President of the White Fuel Company which is located at 12 Hylestead Street. The petitioner stated that these streets are used only by the abutters, who all agree that these streets should be abandoned in order that security, safety and beautification of the area be enhanced.

The petitioner stated that there are many break-ins, fires and general destruction of property, and that if petition were granted a fence would be erected and the area would be landscaped.

Field inspection revealed that Clarke and Towner Streets are unimproved narrow dirt roads used infrequently by delivery trucks and few passenger cars. Towner Street is bordered on the east by a chain link fence separating it from Route 95. Trucks deliver goods to Manchester Silver Company, a building located on the corner of Pavilion Avenue and Towner Street. The delivery door fronts on Towner Street.

The rest of the land abutting Towner and Clark Streets is vacant and unimproved except for Lot No. 160 containing two structures: a two-family building (unoccupied) and an antique repair shop, both in poor exterior condition; and Lot No. 158 occupied by a one-family building in fair exterior condition. Main access to this one-family building is from Hylestead Street.

According to the Tax Assessor's records, Lots 159, 160, 162, 164, 165, 167, 170 and 428 are owned by the petitioner; Lot No. 168 is owned by Charles J. Ajootian and James P. Ajootian and the rest of the area on the block is owned by Manchester Silver Co., Inc.

Field inspection revealed a congested parking situation on Pavilion Avenue where employees of Manchester Silver Company parked cars on both sides of the street. The abandonment of Clarke and Towner Streets will cause inconvenience to the local vehicular traffic and make it virtually impossible for delivery trucks to deliver goods to Manchester Silver Company. The lack of adequate access to the properties in case of fire and the necessity of removal of water lines from Towner and Clark Streets make this proposal of abandonment questionable.

Research revealed that a similar petition was a subject of City Plan Commission consideration in May, 1969. At that time the City Plan Commission voted denial of petition.

Upon motion of Mr. Dulgarian and seconded by Mr. Caldwell the City Plan Commission voted to offer no objection to the granting of this petition with the stipulation that the other property owners in the area join as petitioners; that the State relinquish its half interest in Towner Street; and that the Fire, Police Departments and Water Supply Board also approve the petition.


