No. 247 **AN ORDINANCE** IN AMENDMENT OF SECTION 2-300, OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, RHODE ISLAND, EFFECTIVE OCTOBER 21, 1968, RELATIVE TO PAYMENT OF ELECTION OFFICIALS, AS AMENDED.

Approved March 23, 1979

Be it ordained by the City of Providence:

SECTION 1. Section 2-300, of the Code of Ordinances of the City of Providence; Rhode Island, Effective October 21, 1968, is hereby amended to read as follows:

"Sec. 2-300. Payment of Election Officials,

"Every warden and clerk appointed under the provisions of Title 17 of the Rhode Island General Laws, 1956, or any amendment thereof or addition thereto, shall be paid ^{RAM} ~~seventy~~ ^{thirty-five} (\$~~70.00~~^{35.00}) dollars for services rendered at the polling place at elections. Every supervisor appointed under said provisions of said Title 17 shall be paid ^{RAM} ~~sixty~~ ^{thirty-five} (\$~~60.00~~^{35.00}) dollars for services rendered at the polling place at elections."

SECTION 2. This Ordinance shall take effect upon its passage.
