Be it ordained by the City of Providence:

SECTION 1: Chapter 987 of the Ordinances of the City of Providence as approved September 16, 1955, and entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by appropriating the sum of five hundred (\$500.00) Dollars to the DEPARTMENT OF RHODE ISLAND DISABLED AMERICAN VETERANS CONVENTION.

SECTION 2: The money hereby appropriated shall be paid to the Treasurer of the 1956 Department of Rhode Island Disabled American Veterans Convention Committee, to help defray expenses of the Annual State Convention of the Department of Rhode Island Disabled American Veterans to be held in the City of Providence, June 21, 22 and 23, 1956.

SECTION 3: The said sum of Five Hundred (\$500.00) Dollars as hereby appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 4: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by the sum of Five Hundred (\$500.00) Dollars.

SECTION 5: This Ordinance shall take effect upon its passage.






