PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

Now comes your petitioner, Mr. Angelo Conti, of 81 Carleton Street, Providence, Rhode Island, owner of certain real estate located at 46 and 48 Baxter Street, and 258 Potters Avenue, Providence, Rhode Island, being Plat #48, Lots # 772 and 775, said property presently being zoned as an R-3 district.

Said property is presently unoccupied and not being used in accordance with its present zoning designation. Immediately adjacent thereto are certain properties designated as M-1. The character of this particular neighborhood has changed substantially from residential to business and manufacturing over the past several years.

Therefore, your petitioner respectfully prays that his property be re-zoned so that said premises may be designated M-1.

Your petitioner further respectfully represents that to permit such re-zoning would not in any way be detrimental to the neighborhood, and that to refuse said request would cause to your petitioner an unnecessary hardship in that said premises are not now fit or useable for dwelling purposes, and cannot be used therefor; that to require said premises to remain idyl and unused would be an undue hardship tantamount to confiscation; and that the use of the premises for the purposes herein prayed would do substantial justice, would be in keeping with the spirit of the ordinance, and would promote public safety and the welfare of the people of the immediate neighborhood.

Wherefore the petitioner prays that the formal application herewith submitted be granted.

SUBJECT: Referral No. 1639 - ZONING CHANGE AT 46 & 48 BAXTER STREET, AND 258
POTTERS AVENUE

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Wednesday, September 6, 1967.

This referral is a request to change from an R-3 Zone to an M-1 Zone Lots 772 and 775 on Assessor's Plat 48 located at 46 & 48 Baxter Street, and 258 Potters Avenue.

On an inspection and photographic survey it was determined that Lot 775 contained two, 6-car masonry garages and a small one-story frame building facing Potters Avenue. One 6-car garage fronts on Baxter Street. Lot 772 contains a 2½-story frame dwelling, vacant and in dilapidated condition. The surrounding area is in fair to good condition.

These two lots are located in the Lower South Providence G.N.R.P. Area which consists mostly of two- and three-family houses. Any further expansion of industrial use in this area would be far too excessive and would tend to increase traffic and other hazards in an area already too intensively developed. The increase of industrial use would also impair the value of the surrounding homes. The land use character of this medium density residential zone should be protected from the penetration and expansion of industrial uses which contribute seriously to the ravages and blight of residential neighborhoods. Every effort is being made to upgrade rather than downgrade declining neighborhoods. Therefore,




