RESOLVED, That the sum of Four Thousand Five Hundred (\$4,500) Dollars is hereby ordered transferred by the Board of Commissioners of Sinking Funds from the "Fire Insurance Fund" established by Section 38 of Chapter 2 of the Revised Ordinances of 1946, entitled, "Fire Insurance Fund" to a separate account in the Capital Fund to be known as, "JOSLIN STREET RECREATION CENTER FIRE DAMAGE FUND".

Said sum or so much thereof as may be necessary shall be expended in repairing the fire damage and replacing the equipment destroyed at Joslin Street Recreation Center, said building having been damaged and equipment destroyed by fire.

Any balance remaining in said fund at the completion of repairs and replacement of equipment shall revert to the "Fire Insurance Fund".
