RESOLUTION OF THE CITY COUNCIL

No. 173

Approved April 14, 1978

RESOLVED, That the sum of Forty Thousand (\$40,000.00) Dollars is hereby ordered transferred by the Board of Commissioners of Sinking Funds from the "Fire Insurance Fund" established by Section 38 of Chapter 2 of the Revised Ordinances of 1946 entitled "Fire Insurance Fund" to a separate account in the Trust and Special Funds to be known as "City of Providence Junior Police Camp" in the Revolving Fund (6-63-01).

Said sum or so much thereof as may be necessary shall be expended for the construction of a new Cafeteria Building at Camp Cronin, known as the Providence Junior Police Camp, said building having been damaged by fire, necessitating a new building. Said work shall be done by contract under the supervision of the Acting Chief of Division of Public Buildings acting under the direction of the Director of the Department of Recreation, and payments shall be made against said fund upon vouchers duly approved by the Acting Chief of Division of Public Buildings. Any balance remaining in said fund at the completion of construction shall revert to the "Fire Insurance Fund".

RE: CAMP CRONIN


With regard to your request for a legal opinion involving the aforementioned, please be advised that Camp Cronin was obtained by the City of Providence from the Federal Government in 1958.
