*Whereas,* Active in Civic, Social and Religious affairs, he was a member of the Executive Democratic City Committee, Chairman of the Third Ward Democratic Committee, former President and Director of the John E. Fogarty Center, one of the founders of the Parents Council of Retarded Citizens, together with numerous other organizations and sports activities, and

*Whereas*, W. Earl Dodd, now eighty years of age, was the oldest Stockbroker in Rhode Island and retired on March 19, 1982, as the "Dean of Stockbrokers of the State of Rhode Island",

*Now, Therefore, Be It Resolved*, That the Members of the City Council join with his legion of friends to acknowledge their gratitude and appreciation to W. Earl Dodd for his many years of dedicated public service and hereby designate him "City Clerk Emeritus".
