ORDINANCES SECOND READING

The following Ordinances were in City Council February 1, 1979, Read and Passed the First Time as Amended, and Are Returned for Passage the Second Time:

An Ordinance in Amendment of Section 14-202 Entitled, "Licenses Required" and Section 14-206 Entitled, "License Fees for Bagatelle, Billiard, Pool or Sippio Tables," and Adding Section 14-202.1 Entitled, "Amusement Centers and Mechanical Devices — Definition," as Amended.

Be it ordained by the City of Providence:

Section 1. That Section of 14-202 entitled, "License required", of the Code of Ordinances of the City of Providence, Rhode Island, is hereby amended to read as follows:

"No person shall engage in the business of an amusement center or the keeping of bagatelle, billiards, pool or sippio tables or any mechanical amusement device as defined in Section 14-202.1 for public hire or in the business of keeping such persons shall be duly licensed by the Bureau of Licenses."

Sec. 2. That Section 14-202.1, "Amusement centers and mechanical amusement devices — Definition", shall be added as follows:

For the purposes of Section 14-202 the following definitions of mechanical amusement device and amusement center shall apply.

A. Amusement center — any place having three (3) or more mechanical amusement devices for public hire.

B. Mechanical amusement devices — Any machine, which upon the insertion of a coin, slug, token plate or disc, may be operated by the public generally for use as a game or amusement whether or not registering a score and whether its operation demands skill or chance or both. It shall include but not be limited to such devices as marble machines, mechanical pool tables, pin-ball machines, skill ball, mechanical grab machines, video or computer type games, electronically operated or displayed games, air games such as air hockey, and all games, operations or transactions similar thereto under whatever name they may be called.

Sec. 3. That Section of 14-206 entitled, "License fees for bagatelle, billiard, pool or sippio tables", of the Code of Ordinances of the City of Providence, Rhode Island, is hereby amended by inserting the words following "tables", "or amusement centers" and will read as follows:

"The annual fees for licenses to keep bagatelle, billiard, pool, sippio tables or an amusement center, shall be as follows:

Sec. 4. This Ordinance shall become effective sixty (60) days upon approval by His Honor the Mayor.

An Ordinance in Amendment of Article III, Chapter 9, of the Code of Ordinances of the City of Providence, by Adding Section 9-79 Entitled: "Motor Fuel Dispensing Stations", "Providing for Free Air and Water Service for Patrons of Said Stations," as Amended.

Be it ordained by the City of Providence:

Section 1. Section 9-79 is hereby added to Article III, Chapter 9, to be Entitled, "Motor Fuel Dispensing Stations", as follows:

"Section 9-79 Motor Fuel Dispensing Stations. All Motor Fuel dispensing stations shall have on its premises, and available to all patrons of said station, regular patrons or other, whether making a purchase or not, facilities for dispensing of free air and/or water and the same shall be in working order during hours of operation of said station."

Sec. 2. This Ordinance shall take effect upon its passage by the City Council and Approval by the Mayor.

Whereas, In 1940 Reverend Martinkus was appointed Pastor of the Church in Zidikai, following which he encountered difficulties under the Russian and German occupation, and upon advice from his Bishop he withdrew himself from the imminent dangers to Germany where he became Chaplain to the many Lithuanians in several displaced persons camps, where through his untiring efforts, hundreds of Lituanians were released and saved from deportation to Siberia, and

Whereas, In 1950, by invitation of Bishop Mc-Vinney, he came to these United States, where from 1952 to 1963 he was Assistant Pastor at Saint Casimir's Church, and from 1963 to the present, has continued on as Pastor of said Church, and

Whereas, Father Martinkus, over the years, gave of himself untiringly, his energy and zeal reached far beyond the borders of his Parish, and

Whereas, To honor this occasion befittingly,

parishioners and friends of Reverend Martinkus have planned "Father Martinkus Day" to be March 4, 1979 on which date a Concelebrated Mass at Saint Casimir's Church will be held, followed by a Birthday Banquet to honor him for the devoted and compassionate Pastor that he is, and

Whereas, The Rhode Island Public Buildings Authority (the "Authority") is a body corporate and politic, created pursuant to and existing under the Rhode Island Public Buildings Authority Act, constituting Chapter 14 of Title 37 of the General Laws of Rhode Island, 1956 (1977 Re-enactment) as amended (the "Act") and is authorized pursuant to the Act to issue revenue bonds for the public purposes set forth in the Act and to expend the proceeds thereof to provide for the acquisition, construction, equipping and installation of a State Judicial Complex for Providence County on certain real estate in the City of Providence, Rhode Island (the "Project") (said Project being more particularly described in Schedule A attached hereto and made a part hereof) which will be leased by the Authority to the State of Rhode Island and Providence Plantations (the "State"); and

Whereas, The Authority has determined that such Project is necessary and desirable in order

to benefit the people of the State and to provide for their general health and welfare and to maintain the high standards of public facilities within the State; and

Whereas, Pursuant to the Act, the Governor of the State has requested the Authority to undertake the acquisition, construction, equipping and installation of the Project; and

Whereas, Section 3 of the Act provides that the Project shall be approved by resolution of the City Council of the City of Providence prior to the issuance of revenue bonds by the Authority to finance the Project, which revenue bonds shall be payable from revenues derived from leasing of the Project to the State;

Now, Therefore, be it Resolved by the City Council of the City of Providence that:

1. The acquisition of certain real estate in the City of Providence described in Schedule A attached hereto, and the construction, equipping and installation thereon of the Project by the Authority, and the leasing of the Project to the State be, and they hereby are, approved in all respects.
