I am in receipt of your correspondence dated September 11, 1985 relative to the Federal Hill Parking Lot Association taking over the lease of the Federal Hill Businessmen's Association.

As I informed you by telephone, I was going to review the matter with the City Solicitor as to whether or not a Resolution would have to be presented to the City Council in accordance with your request. He has advised me that the Federal Hill Parking Lot Association must submit a request to the Committee on City Property to lease the Parking Lot, as the lease agreement and Resolution are under the Federal Hill Businessmen's Association.

It is his opinion that if that Association is no longer in existence, the lease rightfully should be terminated.

I suggest you send a request to Councilman Andrew J. Annaldo, Chairman of the Committee on City Property, in care of the City Clerk's Department, so that the matter may be reviewed by that Committee.





Please be advised that the Federal Hill Business Men's Association's charter is no longer in force.




