WHEREAS, on June 6, 1967 the Committee on City Property of the City of Providence offered for sale by sealed bid the former Manton Avenue Fire Station and on that date Carnevale Bros. Fence Co.,^{Inc.} was the successful bidder with a bid of \$18,102.50; and

WHEREAS, on August 17, 1967 the City Council by resolution authorized the sale of said property to the high bidder for a sum of \$18,102.50; and

WHEREAS, during the interval from the bid and the authorization of sale the subject property was damaged by vandals in an amount in excess of \$6,000; and

WHEREAS, the successful bidder is not willing to receive a conveyance for the building in the condition that it is,

NOW, THEREFORE, be it resolved that his Honor the Mayor be and he is hereby authorized to execute a deed of conveyance to Carnevale Bros. Fence Co.,^{Inc.} 380 Valley Street, Providence, Rhode Island, of that certain lot or parcel of land with all the buildings and improvements thereon known as the former Manton Avenue Fire Station and situated at 756 Manton Avenue, said parcel being Lot No. 190 on City Assessor's Plat 34, containing 30,787 sq. ft. in consideration of the sum of THIRTEEN THOUSAND FOUR HUNDRED (\$13,400) DOLLARS,

AND BE IT FURTHER RESOLVED that Resolution No. 490 of the City Council approved August 18, 1967 is hereby repealed.



WHEREAS, "The Rhode Islander" issue of "The Providence Sunday Journal Magazine" for October 13, 1968 included an article entitled "Barrington Discovers Poverty" by Mr. Charles Bakst, which reported in part the following language, "People here don't worry about Negroes," says a local real estate agent. "They worry about Italians," the quote being attributed to a local (Barrington) real estate agent, and

WHEREAS, the connotation of this quote, aside from being in bad taste, in the opinion of many Americans of Italian descent, who have read and reported upon the subject, had the tendency to create the impression that two races of peoples, Italians and Negroes, cause worry, in Barrington, to its residents and imply that they do not make desirable residents of the Town of Barrington, Rhode Island in the United States of America, and

WHEREAS, albeit the Town Council of Barrington, through its President; a former Democratic Town Committee Member; and approximately one hundred and fifty persons have voiced their objection of that opinion, alleged to have been a quote from a local real estate agent, it would appear that the contributions made to the Town of Barrington, by the immigrant Italians and their succeeding generations of children are indelible, cannot be erased by a personal opinion, and of course is not subscribed to by the proponderence of fair minded residents of that Town.

NOW THEREFORE BE IT RESOLVED, that for the sole purpose of "Clearing the Air" of the affrontry, caused by the reporting of that absolutely unnecessary personal opinion, which may have been uttered in a moment of uncontrolled passion, the sponsor of this Resolution joins with all who have been offended by this matter in suggesting that the Providence Journal cause the person making the statement be identified so that he may tender his or her apology publicly to the Americans of Italian-Descent, alluded to in that article as "Italians", and to the Negro Americans whose collective contributions to the colonization of Barrington fraternity, was never questioned when called upon to defend the United States of America.
