Dear Council President Easton and Honorable Members:

In January of 1986 I decided to move back home to Rhode Island from Scituate, Massachusetts with my two teenage sons. From January to June of 1986 I looked extensively for an affordable home in the Rhode Island area. After many months of searching for a home I could afford I found a small house in Greenville, Rhode Island which I purchased in June of 1986 with the financial help of my former husband.

During this same timeframe I looked for employment in the Rhode Island area. In July of 1986 after many job interviews I was offered a position on Mayor Paolino's staff in the Department of Administration. This was a most exciting opportunity for me as I was formerly employed by the City of Providence from 1962 to 1968 at which time I was secretary to Mayor Joseph A. Doorley, Jr.

I am aware of the Home Rule Charter provision which requires city employees to be residents of the City of Providence. However, to date I have not been able to sell my home in Scituate. This means I am temporarily responsible for two mortgage payments. This is a tremendous financial hardship on myself and my former husband. Needless to say, until my home in Scituate is sold I am not in a position to move again at this time. I feel confident that the house will sell in the next few months. Therefore, I am respectfully requesting a six month extension to the resident requirement under Section 1210 of the Home Rule Charter to enable me to move into the City of Providence.
