WHEREAS, The failure to promptly collect trash and recycling in the City has resulted in a buildup of trash and debris along the City's rights-of-way which degrades the quality of life for local residents; and

WHEREAS, The City of Providence has a contract with Waste Management which requires the company to conduct scheduled trash and recycling collection throughout the City; and

WHEREAS, The continuing inability of Waste Management to regularly remove yard waste, trash and recycling in the City, if not immediately addressed, will result in serious health and public safety hazards for the residents of Providence.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby requests that the City Solicitor and the Director of Public Works review and impose all penalties and provisions of the City's contract with Waste Management.

Resolution Requesting the Rhode Island General Assembly amend Rhode Island General Law §3-7-19 to allow the Providence Board of Licenses the authority to exempt from the provisions of said section any Class B License for the property located on Assessor's Plat 6, Lot 595 (737 Hope Street).

WHEREAS, Little Sister restaurant, located at 737 Hope Street is seeking to obtain a class b liquor license in order to better serve their customers; and

WHEREAS, 737 Hope Street is within 200 feet of the Mount Hope Community Baptist Church which would prevent Little Sister from obtaining a liquor license at the property without first receiving an exemption from Rhode Island General Law §3-7-19; and

WHEREAS, The owners of Little Sister have discussed their proposed liquor license application with the Mount Hope Community Baptist Church and did not receive objection to seeking an exemption with the Rhode Island General Assembly.

NOW, THEREFORE, BE IT RESOLVED, That the Members of the Providence City Council hereby request that the Rhode Island General Assembly amend Rhode Island General Law §3-7-19 to allow the Providence Board of Licenses the authority to exempt from the provisions of said section a class b liquor license for the property located at 737 Hope Street (Plat 6, Lot 595).

Resolution Endorsing and Urging Passage by the General Assembly of Senate Bill 2021 S-0155, An Act Relating to Food and Drugs - Single-Use Plastic Straws.

WHEREAS, Eight million tons of plastic end up in the ocean every year, including plastic straws which harm marine ecosystems and represent the seventh most collected item of beach litter; and

WHEREAS, Although disposable plastic straws are only used for an average of 20 minutes before being discarded, they can take as much as 200 years before they biodegrade; and

WHEREAS, Single-use plastics were identified as one of the largest contributors to marine plastic pollution, which is why Earth Day 2018 focused on a global effort for ending plastic pollution; and

WHEREAS, As the Ocean State, Rhode Island's economy relies heavily on our marine environment and a statewide plastic straw reduction effort is vital to maintaining the health and well-being of our marine ecosystems; and

WHEREAS, The issue of single use plastic waste is of major concern to the Providence City Council which is why, in April of 2019, the council passed the Retail Plastic Bag Reduction Act banning the use of single use plastic bags in the City; and

WHEREAS, Senate Bill S-155 aims to address the single use plastic straw issue by prohibiting food service establishments from serving single-use plastic straws unless specifically requested by the consumer; and

WHEREAS, Senate Bill S-155 was passed by the Rhode Island Senate on May 4, 2021 and has been referred to the House Committee on Environment and Natural Resources; and

WHEREAS, It is in the best interests of the health, safety and welfare of citizens of and visitors to Rhode Island to protect our environment and our natural resources by reducing the distribution of single-use plastic straws.

NOW, THEREFORE, BE IT RESOLVED, That the Members of the Providence City Council hereby endorse and urge Passage by the Rhode Island House of Representatives of Senate Bill S-155, An Act Relating to Food and Drugs - Single-Use Plastic Straws Act.
