### AN ORDINANCE

GRANTING A TAX EXEMPTION OF \$3,000.00 TO OWNERS OF MOTOR VEHICLES EQUIPPED FOR THE HANDICAPPED, AS AMENDED.

Approved August 26, 1983

### Be it ordained by the City of Providence:

SECTION 1. (a) The City Council of the City of Providence is hereby authorized to grant an exemption of Three Thousand Dollars (\$3,000.00) from the excise tax on motor vehicles to any person who owns a motor vehicle which has been specially equipped for use by handicapped persons.

(b) Such exemption shall be granted upon the submission of an affidavit from the applicant's physician that he or she is a paraplegic or suffers from paraplegia.

(c) No person shall be entitled to any such exemption in any year unless he or she shall have completed an application form to be provided by the City Assessor. Each application shall be sworn to by the applicant under penalty of perjury.

(d) This exemption shall apply only to drivers with so-called "E" drivers license in whose name the exempted automobile shall be registered and no more than one exemption shall be granted to any individual.

SECTION 2. This Ordinance shall take effect upon its Passage.

Dear Mr. Sheehan:

Enclosed please find a draft of the ordinance you requested regarding tax exemption on motor vehicles used by handicapped persons. I have also enclosed copies of R.I.G.L. §44-18-30 (sales tax exemptions) and 31-28-4 et seq., (parking privileges for handicapped).

One problem I have not dealt with is the type of proof of disability the City Council will require (for example, see Providence Code of Ordinances §21-112). Please note that R.I.G.L. §45-18-30(t) requires the car buyer to obtain a doctor's certification that he is paraplegic. If this were also required by the ordinance, this would not help those handicapped persons who are not the owners of the specially equipped motor vehicles.

*Pursuant to our memorandum to you of May 2, 1983 regarding the proposed exemption allowing those driving motor vehicles specially equipped an exemption of \$3,000 on their excise tax bills, we have been informed by the Registry of Motor Vehicles that they are unable to determine the number of individuals so classified.*

*It is our opinion however that this would be a very limited number inasmuch as it would not be granted to all those with "handicapped" or "parking privilege" plates, but rather only to those that required specially equipped motor vehicles.*

With regard to the proposed new exemption for those individuals who have "motor vehicles specially equipped for use by handicapped", I would like to recommend the following:

Paragraph (b) be replaced with the requirement that the applicant submit a copy of his/her driver's license listing a "G" or "E" classification. The Registry of Motor Vehicles informs us that a "G" code allows the driver to drive a vehicle with special handicapped equipment, and that "E" requires hand controls. This would seem easier for the department to administer this new exemption if it were enacted rather than for us to determine what a physician might actually be saying.

Section 2 should be changed to reflect passage as of December 31, 1983. We are in the process of finalizing the 1983 tax roll now; any new exemptions would have to be applied after the fact, by certificate.

We have contacted the Registry to attempt to determine the impact of this bill. As of this writing we do not know how many people would be involved as they do not have any records breaking out these "E" and "G" code restrictions. They have advised us that they will attempt to obtain this information--however, any records would be State-wide and limitations to Providence could only be estimated. Such information will be forwarded as soon as received.
