

- 27 Calla St. - application received 9/30/88 and inspected on 10/7/88. Sidewalk in good condition in most areas. Small break caused by tree root upheaval. One Phase Two list. At this time we do not know when it will be repaired.
- 8 Broom Street - Previously inspected and no evidence of tree root damage.
- 1285 Eddy Street - Several applications on file. This side is tree root damaged and will be included in Phase One repairs for this area. At this time we are not sure when it will be done. Question as to funding by State for the remainder of our sidewalk repair contract.


