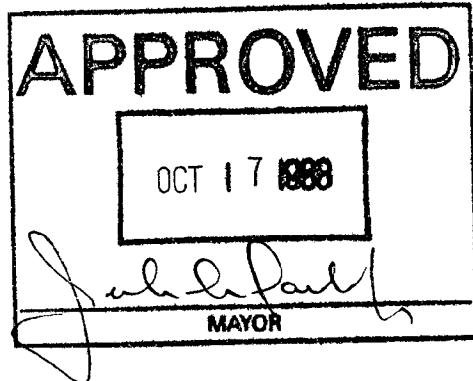
RESOLVED, That Wesleyan Avenue be made a two-way street and "No Parking Anytime" signs be installed along both sides, on a temporary basis.

Be advised that Mr. Jake Kaplan has requested that Wesleyan Avenue be made two-way, currently one-way, on a temporary basis due to expansion and construction of his business facilities. The street being twenty-two feet wide, this would necessitate No Parking Anytime on both sides of the street.

As you are aware, one-way streets or changes in directions of streets require Council passage prior to issuance by the Traffic Engineer of a Traffic Regulation. Please have this matter placed on the Council docket for consideration.
