

Gentlemen:

The Housing Authority of the City of Providence, Rhode Island is developing a housing project at Providence, Rhode Island pursuant to approvals already given by the City Council and the Mayor. These approvals were contained in a Resolution approved January 2, 1958 and a Cooperation Agreement dated January 3, 1950, as amended January 3, 1958.

Section 402 of the Housing Act of 1954 (PL-560, 83d Congress), amending the Housing Act of 1937, as amended, provides that prior to the execution of an Annual Contributions Contract the Local Authority shall notify the governing body of the locality of its estimate of the annual amount of payments in lieu of taxes which will be made for the project and of the amount of taxes which would be levied if the property were privately owned.

We wish to advise you that our estimate of the annual amount of payments in lieu of taxes is \$864.00 and of the annual amount of taxes which would be levied were the property privately owned is \$10,850.00.

We would also like to point out that the actual taxes now being levied upon the site is approximately \$296.80 and that any delinquent taxes will be paid at the time of acquisition of the site.
