Its been almost two months since the City Solicitor's Office rendered an opinion and I would just like to know the status of where the Ordinance is at this point."

COUNCILMAN VINCENT J. CIRELLI, Chairman of the Committee on Ordinances Responds:

"Right Now, Councilman, it's in litigation and the Solicitor's opinion, not so long ago, stated in a letter from the Solicitor's Office that it's a possibility if the Court renders in favor, renders a decision in favor of the people who object to it, we could go into another Public Hearing. So, until the decision is handed by the Supreme Court, the Committee just has to wait for a decision to be handed down."

COUNCILMAN HENRIES further states:

"But, I also understood from the opinion of

the City Solicitor that it would be alright to pass the Ordinance, I have the letter."

COUNCILMAN HENRIES, at this time, reads the opinion from the City Solicitor's Office.

Re: Request for Opinion Relative to Ordinance Prohibiting Discrimination

Dear Councilman:

Your Committee has requested a written opinion regarding the above subject matter. It is our opinion that the committee may pass such an ordinance without General Assembly approval as long as said ordinance is not in conflict with a state statute enacted by the General Assembly. The state has already enacted an anti-discrimination statute and the City may exceed said statute as long as the state has not preempted that area.

The committee may pass such ordinance while

it is in federal court regarding the public hearing aspect of the enacting procedure. This is due to the fact that there has been no orders issued by the court restraining the City from passing any ordinances relating to the above matter.

If the judge rules in favor of the complainants, the Committee on Ordinances may be required to hold a public hearing on the ordinance as originally submitted. This depends on how the judge forms his rule. His rule may be prospective or retroactive; therefore, it may or may not affect you.

COUNCILMAN CIRELLI: "I think the last sentence sums it up Councilman Henries, may or may not affect the Committee, says the Judge's decision may or may not affect the outcome of it."
