CHAPTER 1164

No. 629 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1143 BY APPROPRIATING THE SUM OF TWELVE THOUSAND (\$12,000) DOLLARS TO MUNICIPAL DOCKS, ITEM 7.

Approved November 22, 1957

Be it ordained by the City of Providence:

SECTION 1. Chapter 1143 of the Ordinances of the City of Providence as approved September 20, 1957 entitled: "An Ordinance Making Appropriation of \$36,161,545.40 for the support of the City Government for the Fiscal Year Ending September 30, 1958", as amended, is hereby further amended by appropriating the sum of Twelve Thousand (\$12,000) Dollars to Municipal Docks, Item 7.

SECTION 2. The said sum of Twelve Thousand (\$12,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures to the Receipt Account.


SECTION 3. The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Twelve Thousand (\$12,000) Dollars.

SECTION 4. The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to that account in the Capital Funds known as "Municipal Docks Repair Account". Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.

SECTION 5. This Ordinance shall take effect upon its passage.

No. 630 **AN ORDINANCE** AMENDING SECTION 10 OF CHAPTER 4 OF THE REVISED ORDINANCES OF THE CITY OF PROVIDENCE, 1946, RELATING TO DOGS.

Approved November 22, 1957

Be it ordained by the City of Providence:

SECTION 1. Section 10 of Chapter 4, Revised Ordinances of the City of Providence, 1946, Article II, Dogs, as amended by Chapter 160 of the City of Providence Ordinances of 1948 is hereby further amended to read as follows:

"Section 10. Fees for special constables destroying or listing dogs.

The special constable appointed annually by the Commissioner of Public Safety to kill or destroy or cause to be killed or destroyed, all dogs going at large and not licensed or collared according to law shall receive therefor from the City Treasurer a fee of Six Hundred Seventy-Five (\$675.) Dollars each month and same to be charged to the Police Department appropriation. The special constables appointed annually by the Commissioner of Public Safety to ascertain and make a list of the owners or keepers of dogs and return such lists to the said Commissioner of Public Safety on or before the last day of May shall receive no fees for making such lists and returns."

SECTION 2. This Ordinance shall become effective December 1, 1957.
