As you may know the Commissioners of the Providence Housing Authority recently voted to have the administrative staff presently located at 263 Chad Brown Street, Providence Rhode Island relocate from its present building, making available the facilities for a multi-purpose center to be used by residents of the Chad Brown and Admiral Terrace housing development.

For the past 3 months, I have been looking for quarters without too much success. However, yesterday; March 2nd, I talked with Everett Travisono, Director of Public Property relative to the use of the former Fire Station at the corner of Academy Avenue and Eaton Streets. In fact, yesterday; I viewed the building. Our Chief of Maintenance has taken measurements and assured me that the building will be adequate for our use.

The purpose of my letter is to respectfully request your approval to permit the Housing Authority use of this building for a period of about 2 years, until such time as the Authority may wish to move its administration office into a new development.


