CHAPTER 1033

No. 324 AN ORDINANCE AMENDING SECTION 197 OF CHAPTER 2

OF THE REVISED ORDINANCES OF THE CITY OF PROVIDENCE, 1946,
RELATIVE TO CERTAIN TRAFFIC FINES, ADDING SECTIONS 198 and
199, AND REPEALING CHAPTER 1005 OF THE 1956 ORDINANCES.

Approved May 23, 1956.

Be it ordained by the City of Providence:

Section 1. Section 197 of Chapter 2 of the Revised Ordinances
of the City of Providence relating to the Traffic Engineering De-
partment is hereby amended to read as follows:

"The general penalties provided for by Section 10, Chapter 1,
Revised Ordinances of the City of Providence, 1946, shall apply
to violation of this article or any regulations made thereunder
except that any person electing to appear before the Clerk of
Court instead of a personal appearance before the Police Court
as provided, and admitting the violation charged, shall be
punished by a fine as hereinafter respectively set forth:

OFFENSE

Overtime Parking.....\$1.00
(Provided that for a second such offense within
any 12-month period next following the first con-
viction, the fine shall be \$2; and the fine \$3
for a third such offense, within the 12-month
period next following the first conviction.)

Parking in Prohibited Area (No Parking)..... 3.00
Parking within 8 feet of a Fire Hydrant..... 3.00
Parking in a Loading Zone..... 3.00
Parking in a Taxi Stand..... 3.00
Parking within 25 feet of a corner..... 3.00
Parking to Obstruct a Driveway..... 3.00
Parking on a Sidewalk..... 3.00
Standing in Prohibited Areas..... 3.00
Double Parking *C. more than three (3) feet
from curb) &c.*..... 3.00

(Provided that for a second offense of "Double
Parking" or "Standing in Prohibited Areas" within
any 12-month period next following the first con-
viction, the fine shall be \$4; and the fine \$5
for a third such offense, within the 12-month
period next following the first conviction.)

Parking in a marked Bus Stop..... 3.00
Parking in excess of 1 foot, but not more than 3
feet from curb..... 3.00
Parking with Left Wheels to Curb..... 3.00
Angle Parking..... 3.00
Parking on Marked Crosswalk or within Intersection 3.00
Stopping Bus away from Curb..... 3.00

"Sec. 198. A person charged with the violation of any traffic regulation, and notified in writing by a police officer to appear to answer such charge before the Police Court, instead of personally appearing in court, may in person or by one duly authorized by him in writing, appear before the Clerk of said court, admit the truth of said charge, and pay to said Clerk the designated fine; provided that such appearance, admission and payment be made at the office of said Clerk during regular business office hours, within five (5) days of such notification, and failure to so appear shall be deemed a waiver of the right to dispose of such charge without personal appearance in court. The right to dispose of such a charge without personal appearance in court may not be exercised by any person who in any consecutive period of 12 months next preceding such charge has been three times in the aggregate adjudged guilty by the Police Court of any violation of traffic regulation or ordinances, or has admitted the truth of charges made against him relating to traffic offenses."

"The payment of the fine to the Clerk as herein provided shall operate as a final disposition of the charge, and such proceedings shall not be deemed criminal. Notice of any violation shall indicate the offense charged, and shall also contain such other information as will enable the person charged to take advantage of the provisions of this section."

"Sec. 199. Any police officer may remove and impound, or cause to be removed or impounded, any vehicle parked upon any street or highway, in such a violation of any parking regulation, other than overtime parking, as to constitute an obstruction to traffic. A towing charge not exceeding five (\$5) dollars, plus a storage charge not exceeding one (\$1) dollar for each day or fraction thereof thereafter, shall be paid to the Clerk of the Police Court or some official designated by him before any such vehicle shall be released. The payment of such charges shall not release operator from any penalty imposed for violation of a traffic regulation."

Sec. 3. This Ordinance shall take effect upon its passage, Chapter 1005 approved January 28, 1956 and all other ordinances or parts thereof inconsistent herewith are hereby repealed.

OF THE UNITED STATES, CONVENTION COMMITTEE.

Be it ordained by the City of Providence:

SECTION 1: CHAPTER 987 of the Ordinances of the City of Providence as approved September 16, 1955, and entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by appropriating the sum of Three Hundred (\$300.00) Dollars to the DEPARTMENT OF RHODE ISLAND, JEWISH WAR VETERANS OF THE UNITED STATES, CONVENTION COMMITTEE.

SECTION 2: The money hereby appropriated shall be paid to the Treasurer of the 1956 Department of Rhode Island, Jewish War Veterans of the United States, Convention Committee to help defray the expenses of the Annual State Convention of Department of Rhode Island, Jewish War Veterans of the United States, to be held in the City of Providence, May 27th, 1956.

SECTION 3: The said sum of Three Hundred (\$300.00) Dollars as hereby appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 4: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by the sum of Three Hundred (\$300.00) Dollars.

SECTION 5: This Ordinance shall take effect upon its passage.

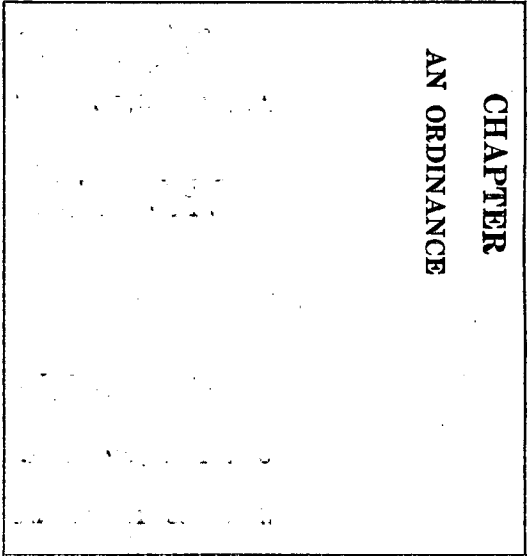

(\$17,000) DOLLARS TO RECREATION DEPARTMENT, ITEM 6.

Be it ordained by the City of Providence:

SECTION 1: Chapter 987 of the Ordinances of the City of Providence as approved September 16, 1955, and entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by appropriating the sum of Seventeen Thousand (\$17,000) Dollars to RECREATION DEPARTMENT, ITEM 6.

SECTION 2: The said sum of Seventeen Thousand (\$17,000) Dollars as thus added and appropriated shall be charged to the General Fund from Funds Not Otherwise Appropriated.

SECTION 3: The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to an account in the Capital Funds to be known as "Purchase of Fort Greene (South Reservation)". Any unexpended balance remaining in this account upon completion of the purchase shall revert to the General Fund.

SECTION 4: This Ordinance shall take effect upon its passage.

(\$150,000) DOLLARS TO PUBLIC WORKS-HIGHWAY SECTION, ITEM 7.

Be it ordained by the City of Providence:

SECTION 1: Chapter 987 of the Ordinances of the City of Providence as approved September 16, 1955, and entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by appropriating the sum of One Hundred Fifty Thousand (\$150,000) Dollars to PUBLIC WORKS-HIGHWAY SECTION, ITEM 7.

SECTION 2: The City Controller and City Treasurer are hereby authorized to transfer Seventy Five Thousand (\$75,000) Dollars from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts are increased as follows:

Reserve for Extraordinary Expenditures Account - \$ 75,000

Property Taxes - Previous Years - 75,000

SECTION 4: The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to the Highway Special II Account in the Capital Funds. Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.

SECTION 5: This Ordinance shall take effect upon its passage.

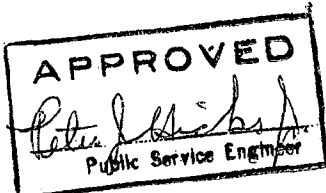
