





**DISPOSITION:** Denied. This intersection does not meet the warrants for a traffic signal system. We will establish a four-way stop control at this intersection.

Re: Petition Concerning Ravenswood and Ardmore Avenues

Dear Councilman Butler:

As I have indicated to you in our previous correspondence, the residents of Ravenswood Avenue have expressed great concern over the current traffic situation on our street. During peak hours on Smith Street, in particular the afternoon hours when the local schools are releasing the children, Ravenswood Avenue is used as a cut-through to avoid the Smith Street traffic and the traffic light at Gention Avenue. This causes an unusually heavy traffic flow through our neighborhood, and the problem is compounded by the fact that the cars cutting through travel in excess of the posted speed limit. We are concerned with maintaining the tranquility of our neighborhood and, more importantly, preserving the safety of our children.


Enclosed please find a petition expressing the desire of the residents of Ravenswood Avenue to have a four-way stop sign at the intersection of Ravenswood and Ardmore Avenues. I have canvassed the neighborhood and have encountered full support for this proposal.

In addition, I have received a suggestion that a "traffic calmer" be installed and that Ravenswood be made a one way street. I am also enclosing a plat map and measurements showing the feasibility of a "traffic calmer". It is noteworthy that, as shown on the map, traffic diverted from Ravenswood would likely remain on Smith Street and not be pushed to a neighboring side street. There is no side street other than Ravenswood which provides a "cut through" from Smith to Gention.

Finally, it is my understanding that you have spoken to one of my neighbors concerning making Ravenswood a one way street. In order to properly discourage "cut through" traffic both from Gention and Modena Avenues, I would suggest that Ravenswood be divided from the intersection with Ardmore with the west end becoming one way in the direction towards Gention and the east end one way going in the direction towards Modena.

Please do not hesitate to contact me if I can provide further information. I and several neighbors are available to meet with you or to appear before the council if necessary. I will be on vacation from May 2 through May 12. I look forward to hearing from you.
