



WHEREAS, In an effort to convert vacant lots into productive reuse, the Providence Redevelopment Agency is working to create affordable housing.

NOW THEREFORE, BE IT RESOLVED, That the taxes, in the amount of One Thousand Six Hundred and Forty-Five Dollars and Seventy-Three Cents (\$1,645:73), assessed upon Assessor's Plat 48, Lot 437 (130 Potters Avenue), along with any associated interest, penalties and intervening taxes, while owned by the Providence Redevelopment Agency, are hereby abated in whole in accordance with Rhode Island General Law 44-7-23 and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40.
