CHAPTER 1973-23

No. 264 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1972-32, APPROVED JUNE 23, 1972, BY APPROPRIATING THE SUM OF FOUR HUNDRED FIFTY THREE THOUSAND SIXTEEN DOLLARS AND EIGHT CENTS (\$453,016.08) TO VARIOUS DEPARTMENTS.

Approved May 28, 1973

Be it ordained by the City of Providence:

SECTION 1. Chapter 1972-32 of the Ordinances of the City of Providence, as approved June 23, 1972 entitled: "An Ordinance Making Appropriation of \$76,070,746.51 for the Support of the City Government for the Fiscal Period Beginning July 1, 1972 and Ending June 30, 1973", as amended, is hereby further amended by appropriating the sum of Four Hundred Fifty Three Thousand Sixteen Dollars and Eight Cents (\$453,016.08) to the following items and the following departments.

1) SCHOOL DEPARTMENT	ITEM 0	\$420,000.00
2) FICA TAXES (82-04)	ITEM 3	33,016.08

SECTION 2. The said sum of Four Hundred Fifty Three Thousand Sixteen Dollars and Eight Cents (\$453,016.08) as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer Four Hundred Fifty Three Thousand Sixteen Dollars and Eight Cents (\$453,016.08) from the Reserve for Extraordinary Expenditures Account to the Receipts Account.

SECTION 3. The Estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Four Hundred Fifty Three Thousand Sixteen Dollars and Eight Cents (\$453,016.08).

SECTION 4. This Ordinance shall take effect upon its passage.
