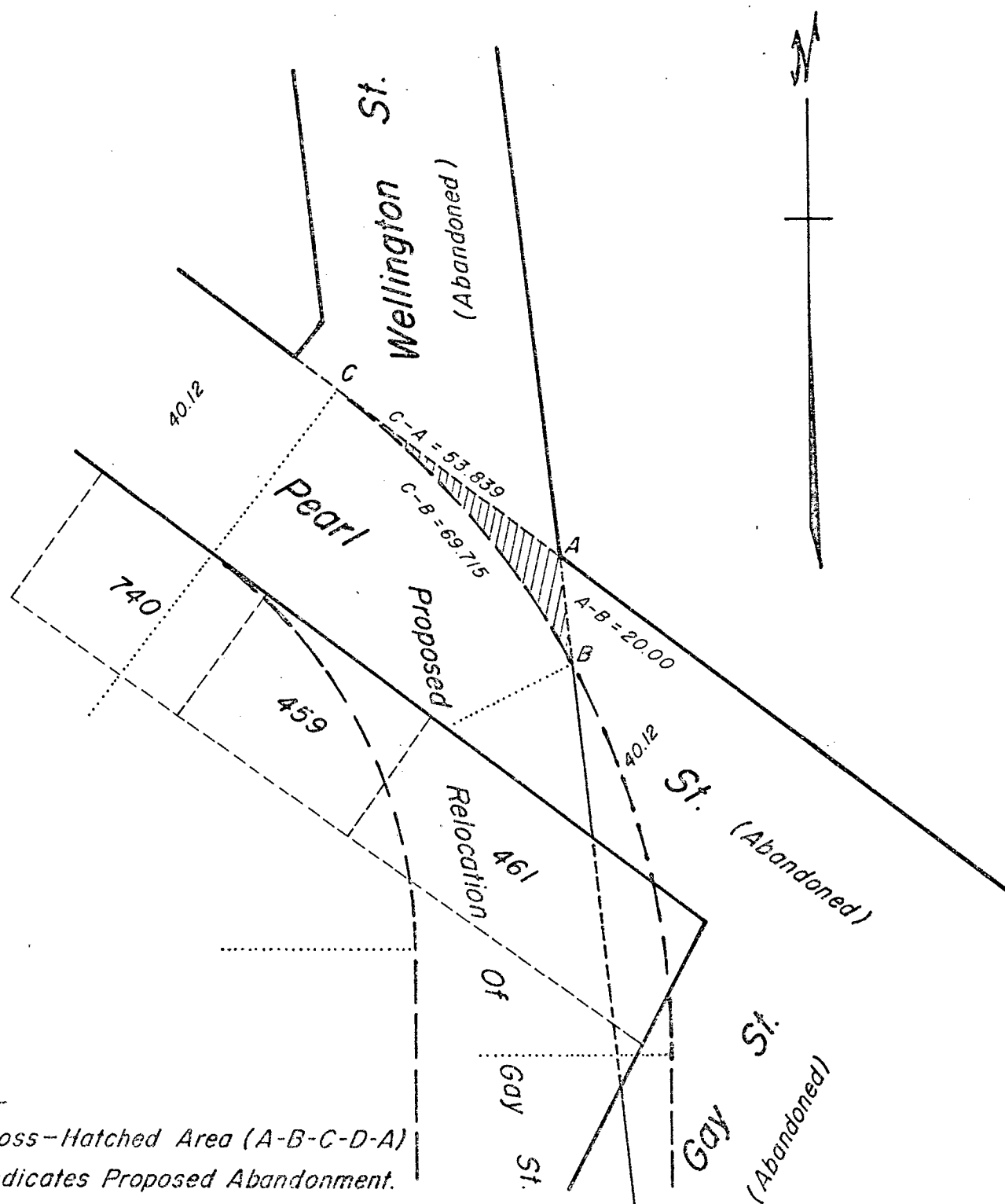



RESOLVED, DECREED AND ORDERED:

That the following named highway shown as shaded areas on the accompanying plan entitled "Providence, Rhode Island, Department of Public Works - Engineering Office, Street Line Section Map no. 063834, dated July 8, 1974",

viz:

Pearl Street (portion) at the intersection of Wellington Street as shown in Area (A-B-C-D-A), having ceased to be useful to the public and the same are abandoned as public highway and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words "Not a Public Highway," and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which have been abandoned, who is known to reside within this State.

**TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:**

*The undersigned respectfully petitions your honorable body*  
Abandon as a Public Highway Pearl Street (portion) at the intersection of Wellington Street.

Proposed Abandonment  
(Portion of Pearl Street)

That certain tract or parcel of land situated on Pearl Street at the intersection of Wellington Street in the City of Providence, R.I., shown as cross hatched area and designated by the letters A-B-C-A on the accompanying plan entitled, "Providence, R.I., P.W. Dept. Engineering Office, Street line Section, Plan no. 063834, Date July 8, 1974", bounded and described as follows:

Beginning at a point marked "A" on the accompanying plan said point being the former southeast intersection of Pearl Street and Wellington Street; thence southerly along the range of the former easterly street line of Wellington Street twenty (20.0') feet to a point on the arc of a curve in the proposed relocated Gay Street and point marked "B" on the accompanying plan thence in a generally westerly direction on a arc of a curve to the left sixty nine and 715/100 (69.715') feet to point marked "C" on the accompanying plan; thence southeasterly along the northerly line of Pearl Street fifty-three and 839/1000 (53.839') feet to point marked "A" on the accompanying plan; said point being point and place of beginning.

Said parcel herein described contains 220 ± square feet.
