

Your appointment as the Director of Personnel has been referred to that Committee, and prior to approval by the City Council, as is customary, the members meet with all appointees.

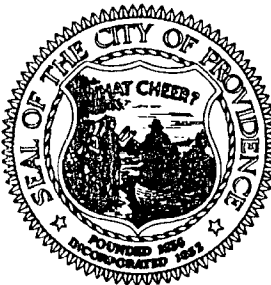
