
WHEREAS, To effectuate its goal of redevelopment, the Providence Redevelopment Agency (the "Agency") has transferred real property to the Dirt Palace Public Projects formerly held by the Agency located at 514 Broadway, Assessor's Plat 035, Lot 584, Providence, RI 02903.

NOW, THEREFORE, BE IT RESOLVED, That the taxes in the amount of Twenty Five Thousand Fifty One Dollars and Fifty Eight (\$25,051.58) Cents, assessed upon 514 Broadway, Assessors Plat 035, Lot 584, along with any associated interest, penalties and intervening taxes are hereby abated in whole and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40 while under PRA ownership.




