




Dear Ms. Mendonca:

We are in receipt of resolution number 625 in which you asked us to respond to the City Council's concern regarding the dumpsters on Eddy Street behind our Hotel. For some time now we have been working on the resolution of this matter ourselves. At present we have hired an architect to establish a dumpster area that would completely enclose a new compactor type dumpster that would partially extend out on to Eddy Street. This should solve the problem of litter and odors.

At present our plans have been passed by all appropriate City agencies including the Health Department, Fire Department and the Building Department. We are presently going out for bids on this job and expect to receive back bid proposals within the next thirty to forty-five days. At that time we will be assessing the financial feasibility of this proposal and will be making a decision.

I hope this answers any questions that the City Council may have.


WHEREAS, The City of Providence is undertaking a Clean-Up Campaign to beautify our City and for the health and welfare of its Citizens, and
