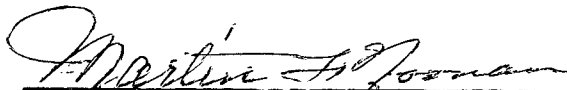

Gentlemen:

I have the honor to submit to you the
Annual Report for the Park Department for the year
ending September 30-1954.


Superintendent of Parks

We are glad to report that all property throughout the entire Park System has been maintained in the best possible condition. We always conduct our routine work on a high order as we figure this method involves less expense in the long run.

We do all repair work on buildings, bridges, roads, sidewalks, animal pens, fences and grounds as it becomes necessary; this means less deterioration; also, our usual routine planting, care of trees and shrubs, trimming, spraying, clean-up of roads, etc.

An off-street parking lot has been built in Roger Williams Park which will accomodate approximately one hundred cars. This will relieve traffic congestion to a great extent in the center of the park and near the amusements in this area which tend to impede traffic; also in the area of the Oriental Garden.

Our tulip display, always an outstanding feature in Spring, was exceptionally attractive this year and was visited by many out-of-state people as well as by thousands of our own residents. In addition to this beautiful showing - the azaleas, flowering cherry, crab and dogwood trees together with numerous other spring blooms all seemed to out-do themselves this past spring in an array of brilliant color and beauty.

In June our extensive Rose Gardens including both hybrid and climbing roses were a genuine treat for the thousands of visitors to the park during July and continuing practically all through the summer.

The Chrysanthemum Show early in November attracted the usual enthusiastic crowds of flower lovers. Thousands visited this beautiful exhibit held in our Park Avenue greenhouses and we received numerous compliments on this fine exhibition. We displayed hundreds of unusual blooms including many new species being introduced to the public for the first time.

Our Christmas Display continues to draw large crowds not only from our own state but from neighboring states as well. We have plans in mind for an improvement in this project which we hope we may be able to inaugurate for next year's scene.

MUSEUM

During the past year our Museum Building has been completely re-wired: unsightly old fixtures have been replaced with modern fluorescent lighting. This made a very fine improvement besides being urgently needed.

The large numbers attending our Museum of Natural History continue to be keenly interested in the various exhibits and classes, and also in our Planetarium which serves as a special source of instruction to many adults as well as students and is very much appreciated. In addition to the usual showings for school children, we hold special sessions for groups of students interested in astronomy.

GOLF COURSE

We are glad to report that we had a very successful playing season at our Municipal Golf Course. To meet the popular demand for this recreation, the course was kept open through December 20th. A total of 46,317 rounds of golf were played as follows:

32,265 daily permits
14,052 rounds by season pass players

The greens and fairways have been maintained in splendid condition.

DEXTER TRAINING GROUND

During the past year, the Park Department has extended the landscaping project at Dexter Training Ground. We graded about two-thirds of the entire area and planted grass seed which is developing into a fine turf.

Also, four bocchia courts have been constructed and flood-lighted; this game meets a demand for a very popular form of recreation for the residents of this neighborhood. New benches were installed and, all in all, it added up to a very good improvement of this property.

HURRICANES

Park property throughout the entire city was extremely hard hit by two severe hurricanes this past Fall. Approximately 2500 trees were badly damaged; numerous others were damaged in a lesser degree - limbs broken, etc. and close to 1500 trees were up-rooted.

A number of our real old trees were ruined beyond reclaiming, and it will take many years to replace some of the rare priceless species in Roger Williams Park's noted collection. In a good many instances where they were up-rooted and not too badly damaged, we were able to save the trees by setting them back into position and securing them by the use of guy wires.

A large section of the cement wall around the brook at Pleasant Valley Parkway was undermined and broken away.

A great many tropical plants in beds on the Mall were ruined by oil and flood waters; a large section of the turf in that area and in City Hall Park was destroyed.

Practically all of our buildings were damaged to some extent - and, in the case of the Museum and Casino, the damage was extensive.

All park property has been cleaned up of debris resulting from the hurricane and is being restored to good condition as quickly as possible.

Naturally, the time and labor required for emergency work on hurricane rehabilitation necessitated setting aside other work which had been planned for this fall season.
