RE: PENDING MATTER

REQUEST: That the Traffic Engineer is requested to cause the installation of speed humps along Health Avenue to control excessive speeding.

DISPOSITION: The installation of "speed humps" is a measure used in Traffic Calming. Traffic Calming is a comprehensive study of a neighborhood, not just one street. Due to the enormous number of requests City wide for traffic calming, I am recommending that each Councilperson designate an area in their ward and that a Citywide plan be developed by a consulting firm and paid for from the Neighborhood Bond Account for the study and implementation.

RE: PENDING MATTER

Request: That the Traffic Engineer is requested to cause the installation of speed humps along Health Avenue to control excessive speeding.

Disposition: The implementation of "Traffic Calming" measures is a result of a comprehensive traffic study of a portion of a neighborhood, not just one street. The only area of the City that has implemented traffic calming is in the Elmwood Neighborhood. Due to the many requests for "Traffic Calming", I think the best solution would be to have all Council members submit a list where they feel they would like to have this implemented and fund the study and design from their Bond Monies.

RE: PENDING MATTER

REQUEST: That the Traffic is requested to cause the installation of "Four-way" stop signs along the intersection of Gallup Street and Burnside Street.

DISPOSITION: Denied. The installation of the four-way stop control along Gallup Street and Ocean Street is sufficient. To install two four-way stop controls will only breed contempt for the law and will increase speeding.
