the following named person, firm or corporation is hereby granted permission to erect, alter or use a building or structure at the location named herein for the sale of petroleum, kerosene, gasoline, coal oil and their products, compounds and components as described and shown in and on the application therefor and accompanying plat, all on file in the office of the Inspector of Buildings subject to the conditions that said person, firm or corporation shall not violate any of the laws of the State of Rhode Island or any of the Ordinances of the City of Providence relative to the erection, use or occupation of said structure and that said person, firm or corporation shall not allow petroleum, kerosene, gasoline, coal oil or their products, compounds or components, to be conveyed over or across any sidewalk by means of any pipe or hose, and upon such special conditions as are hereby enumerated, viz;

Ward 8: Antonio Autiello, 252 Cranston Street, Plat 30, Lot 136. Install 2-4,000 gallon and 1-5,000 gallon gasoline storage tanks and remove 1-450 gallon tank making a total storage capacity upon the premises of 13,000 gallons, and two gasoline filling pumps.

The erection or location of any buildings or structures not shown on the original plat on file with the Inspector of Buildings or any change in the location of buildings or structures from that shown on said plat shall be deemed a violation of this permit.

At a meeting of the Zoning Board of Review held on Tuesday, January 28, 1958, the following resolution was adopted:

WHEREAS, Antonio Autiello, owner of Lot 136 on Assessor's Plat 30 on the southwesterly corner of Cranston and Gilmore Streets (252 Cranston Street) in a Commercial C-2 Zone, on January 6, 1958, filed an application for permission to erect a one story masonry addition 9' x 15' to the present building to be used for office facilities and to replace an existing 1250 gallon underground gasoline storage tank with two new underground gasoline storage tanks having a total underground storage capacity of 13,000 gallons of petroleum products and to be relieved from the requirements of Section 26 A-5 relating to corner setback in the proposed erection of an advertising sign 6' x 8' on a 6" steel pole and to relocate the present two fuel pump island, and

WHEREAS, a public hearing was held on this application by the Zoning Board of Review at its meeting held on Tuesday, January 28, 1958, after public notice as provided by the Zoning Ordinance,

RESOLVED: That the Zoning Board of Review does hereby make a variation of the use district regulations and Section 26 A-5 under the Zoning Ordinance and does hereby grant the application of Antonio Autiello in accordance with the plans and plot plan filed with said Board on condition that no additional advertising signs be erected on the premises. A copy of said plans and plot plan are hereby made a part of this resolution and filed with the Director of the Department of Building Inspection.


