




Dear Mr. Whelan:



Mr. ST. GERMAIN introduced the following bill; which was referred to the Committee on Interior and Insular Affairs

A BILL

To provide for the establishment of the Roger Williams National Monument.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the Secretary of the Interior shall acquire by gift, pur-
4 chase with appropriated or donated funds, condemnation,
5 transfer from any Federal agency, exchange, or otherwise,
6 such land (together with any buildings or other improve-
7 ments thereon) or interests in land as the Secretary may
8 deem necessary for the purpose of establishing a national
9 monument on the site of the town spring in Providence,
10 Rhode Island, such site being the spot where the original

1 settlement of the city of Providence was made by Roger
2 Williams.

3 SEC. 2. The property acquired pursuant to the first sec-
4 tion of this Act shall be designated as the Roger Williams
5 National Monument and shall be set aside as a public
6 national memorial to Roger Williams. Such national monu-
7 ment shall be administered by the Secretary of the Interior,
8 through the National Park Service, subject to the provisions
9 of the Act entitled "An Act to establish a National Park
10 Service, and for other purposes", approved August 25, 1916,
11 as amended and supplemented; and the Act entitled "An
12 Act to provide for the preservation of historic American sites,
13 buildings, objects, and antiquities of national significance,
14 and for other purposes", approved August 21, 1935.

15 SEC. 3. The Secretary of the Interior is authorized—

16 (1) to maintain, either in an existing structure
17 acquired pursuant to the first section of this Act or in a
18 building constructed by him for the purpose, a museum
19 for relics and records pertaining to Roger Williams, and
20 for other articles of national and patriotic interest, and
21 to accept, on behalf of the United States, for installation
22 in such museum, articles which may be offered as ad-
23 ditions to the museum; and

24 (2) to construct and maintain therein such markers,
25 buildings, and other improvements, and such facilities

1 for the care and accommodation of visitors, as he may
2 deem necessary.

3 SEC. 4. There are hereby authorized to be appropriated
4 such sums as may be necessary to carry out the provisions
5 of this Act.

QUARTERLY REPORT OF THE QUALITY OF MILK SOLD IN PROVIDENCE BY RETAIL DISTRIBUTORS

The following table gives the results of the average of analyses made by this department during the second quarter of the year 1961:

No distributor's name is listed under a particular grade of milk unless at least four samples of that grade were analyzed during the quarter. The standard plate count of colonies of bacteria is obtained by using the logarithmic average set forth in the United States Public Health Service Milk Code.

CERTIFIED MILK

The legal standards for Certified Milk are those adopted by the American Association of Medical Milk Commissions, Inc. and in effect at the time of production.

Unless otherwise indicated on the label it shall contain an average of 4.0% of butter fat with a minimum of 3.5% for individual samples and a minimum of 12% of total solids.

The average bacterial count of Pasteurized Certified Milk shall not exceed 500 colonies of bacteria per cubic centimeter.

GRADE A MILK—PASTEURIZED

Grade A Pasteurized milk is produced on farms scoring not less than 85% using the dairy score card of the U. S. Department of Agriculture. The butter fat shall average not less than 3.50% for any four samples taken in a period of not less than 30 days or more than 90 days. The bacteria count shall have a logarithmic average of not greater than 10,000 for any 4 consecutive samples.

The Milk Solids Not Fat shall average 8.50%.

PASTEURIZED MILK

The average bacteria count of pasteurized milk at the time of delivery to the consumer shall not exceed 25,000 per cubic centimeter and the average per centum of butter fat shall be not less than 3.25 per centum by weight.

The Milk Solids Not Fat shall average 8.25%.

PASTEURIZED SELECTED MILK

Under state law only three grades of milk are recognized, Certified, Grade "A", and Regular. Milk may also be classified as homogenized, skim, or defatted. Buttermilk and Cultured Buttermilk are other recognized types defined by state law. Goat milk is also defined. All milk sold in the City of Providence is required to be pasteurized.

While there is no separate legal classification of Pasteurized Selected Milk, some dealers utilize this "grade" as a price differential. Check this grade with dealer's Grade "A" or Regular.

REMARKS

While this report covers the second quarter 1961, the months of April, May and June, it is my feeling, that inasmuch as people are at the present time, interested in milk, that the following action taken during the third quarter be printed now :

On August 3, 1961, 500 quarts of milk were dumped at Mt. Pleasant Dairy because of a mechanical failure at the plant, resulting in low solids and fats. Condition has been corrected.

On August 15, 1961, 216 quarts of milk were dumped at Jerry's Dairy because of low solids and fats. This condition was due to poor supply and has been corrected.


Since the matter of "Jug Milk Sales" has stimulated the interest of the public in its milk supply and in the quality of milk coming into homes, it is my feeling that much can be done by the Public to urge the Legislature to raise the standards of milk.

While this report shows the averages according to law, I believe that most people would be interested in knowing the number of samples below standard obtained from individual dealers each quarter. Therefore, in the next quarterly report, I plan to list in parentheses, along side name of Dealer, the total number of samples obtained during the quarter, the number where solids or fats were below standard and the number where bacterial counts were above the standard. Thus:

Dealer's Dairy (10-1-0)...../ 4.25 / 8.68 / 600....
would indicate that there were ten samples taken of this grade of milk from this dealer and 1 butterfat or solids not fat was below standard.

This is the first time in more than 20 years when any averages were below standard.


