No. 411 AN ORDINANCE IN AMENDMENT OF CHAPTER 1982-10 OF THE ORDINANCE OF THE CITY OF PROVIDENCE, AS APPROVED MAY 11, 1987, AS AMENDED IN CHAPTER 1988-45, NOVEMBER 23, 1988, AS AMENDED IN CHAPTER 1989-18, APRIL 17, 1989, AND AS AMENDED IN CHAPTER 1995-4, APRIL 30, 1995; ENTITLED "AN ORDINANCE CREATING AND ESTABLISHING AN ECONOMIC DEVELOPMENT ZONE WITHING THE CITY OF PROVIDENCE PURSUANT TO 3-7-16.4 OF THE GENERAL LAWS OF THE STATE OF RHODE ISLAND," AS AMENDED.

Approved August 8, 1996

Be it ordained by the City of Providence:

WHEREAS, the City Council, pursuant to Rhode Island General Laws Section 3-7-16-4, created and established an economic development zone necessary for the purpose of encouraging commercial and industrial investment; and

WHEREAS, the boundaries of said economic development zone were set forth in Exhibit A of Chapter 1988-45, attached thereto and incorporated by reference; and

WHEREAS, the City Council desires to modify the boundaries of said economic development zone;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PROVIDENCE:

That portion of the economic development zone located "Number 1" attached and incorporated by reference in Chapter 1988-45 as amended, is hereby amended pursuant to R.I.G.L. 3-7-16.4 as shown in Exhibit "A" which was attached to the amendment dated April 30, 1995 (Chapter 1995-4) for the purposes of licensing Class ED Retail Alcoholic Beverages Licenses, is further amended by extending the southerly boundary of the economic development zone within Census Tract 9, in a southerly direction, to a line running parallel to Atwells Avenue and extending one hundred (100) feet from the centerline of said Atwells Avenue.



This Ordinance is being sponsored by Councilman John J. Lombardi.






